A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE CITY MANAGER TO SUBMIT APPLICATIONS FOR THE ALAMEDA COUNTY TRANSPORTATION COMMISSION (ALAMEDA CTC) COUNTYWIDE TRANSPORTATION PLAN

WHEREAS, the Alameda CTC is currently soliciting projects for inclusion in the Countywide Transportation Plan; and

WHEREAS, the Alameda Countywide Transportation Plan (CTP) is a long-range policy that guides transportation investments in the county for a period of 25-30 years; and

WHEREAS, the City Council has adopted plans that contain a number of projects and programs that are eligible for state and federal funding through the Alameda Countywide Transportation Plan process; and

WHEREAS, the City Council upon successful applications, will commit to deliver the projects in a timely fashion and provide the pertinent local match.

NOW, THEREFORE, BE IT RESOLVED, that the Albany City Council hereby authorize the City Manager to submit grant applications for the following projects:

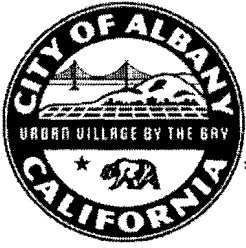
- San Pablo Avenue and Buchanan Street Complete Streets Project – Design and Construction Phases
