**CONFIRMING THE FISCAL YEAR 2015-2016 ADJUSTED RATES
APPLIED TO CITY OF ALBANY SPECIAL TAXES AND FEES
COLLECTED ON THE ANNUAL PROPERTY TAX BILL**

WHEREAS, the City of Albany collects certain local approved special taxes and fees on the County Property Tax Bill; and

WHEREAS, the authorizing measures and actions imposing these fees in some cases allows for an annual adjustment based on the change in the Consumer Price Index; and

WHEREAS, the City's Property Tax Assessment Consultant (NBS Government Services) has calculated the maximum rate of adjustment for each of the subject fees based on a 2.8414 percent change in the Consumer Price Index; and

WHEREAS, staff analyzed the Budget and projected revenues and expenses for each of the subject fees; and

WHEREAS, attached hereto as Exhibit A and by reference made a part hereof, is the Maximum 2015/2016 Rates and the Adjusted 2015/2016 Rates.

NOW THEREFORE, BE IT RESOLVED, that the City Council of the City of Albany does hereby adopt the attached schedule of Adjusted Rates, which shall be used to calculate the subject fees and taxes on the Fiscal Year 2015/2016 tax roll.
