

RESOLUTION NO. 2015-74

A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT AGREEMENT IN AN AMOUNT NOT TO EXCEED \$223,130 WITH ZOON ENGINEERING TO CONDUCT PLAN REVIEW AND CONSTRUCTION MANAGEMENT FOR THE MARIN UTILITY UNDERGROUNDING AND BUCHANAN MARIN BIKEWAY PHASE III PROJECT

WHEREAS, the Buchanan Marin Bikeway Project Phase III is the last segment to be built to close the gap in the bicycle network and is part of the Albany Active Transportation Plan; and

WHEREAS, the project is included in the City Council Strategic Plan section Advance Community Climate Action through the implementation of the Active Transportation Plan; and

WHEREAS, City Council established the Marin Utility Undergrounding District in 2010 to be implemented through the PG&E Rule 20A program; and

WHEREAS, the undergrounding of utilities and the surface realignments that will allow for the extension of the bike lanes along Marin Avenue will be implemented concurrently; and

WHEREAS, the undergrounding of utilities is a very specialized field and the City does not have staff with that level of specialization; and

WHEREAS, on September 18, 2015, the City issued a Request for Proposals from qualified engineering firms to conduct plan review and construction management services for this project; and

WHEREAS, the City received five proposals which were interviewed by a selection panel; and

WHEREAS of the five firms interviewed the selection panel chose Zoon Engineering due to its relevant experience in similar projects and knowledge of the Caltrans Construction Management program;

NOW, THEREFORE, BE IT RESOLVED, that the Albany City Council hereby authorizes the City Manager to execute a contract not to exceed \$223,130 with Zoon Engineering for Plan Review and Construction Management services for the Marin Utility Undergrounding and Buchanan Marin Bikeway Phase III project.
