2 **A RESOLUTION OF THE ALBANY CITY COUNCIL APPROVING**
3 **REVISIONS BY THE ARTS COMMITTEE TO THE PUBLIC ARTS**
4 **MASTER PLAN TO PROVIDE A COMPLETE STATEMENT OF THE**
5 **WORKFLOW, CATEGORIES, AND SELECTION PROCESS RELATED**
6 **TO THE DEVELOPMENT OF PUBLIC ART IN ALBANY AND TO**
7 **INCLUDE A NEW SCULPTURE LOAN PROGRAM**

8 **WHEREAS**, in February 2008, the City of Albany adopted the Art in Public Places
9 Ordinance; and

10 **WHEREAS**, the key source of funding established by the ordinance is a 1.75% for-
11 art fee for certain building developments exceeding \$300,000 in construction costs; and

13 **WHEREAS**, to develop a reasonable and responsive guide for the implementation
14 of the Art in Public Places Ordinance the Public Arts Master Plan was adopted in July
15 2010; and

17 **WHEREAS**, the Arts Committee completely revised the “Public Art Process –
18 Flow Chart Narrative” on pages 54-59 of the Public Arts Master Plan; and

19
20 **WHEREAS**, the new section entitled Public Art Project Categories and Review
21 Process supersedes pages 54-59 in the City of Albany Public Arts Master Plan in order to
22 provide a complete statement of the workflow, categories, and selection process related to
23 the development of public art in Albany; and

25 **WHEREAS**, the flow chart has completely been revised to correspond to the
26 revised section; and

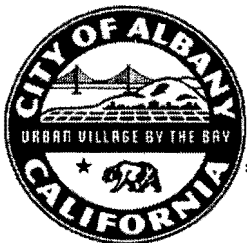
