CALL TO ORDER

Mayor Maass called the meeting to order at 7:30 pm.

8. UNFINISHED BUSINESS

8.1 Funding Capital Improvement Projects – Study Session

Staff recommendation: that the Council conduct a study session to provide direction to staff on:

- a. the type of revenue measure to pursue;
- b. the amount to be generated from the revenue measure;
- c. identify projects or services to be funded

City Manager Penelope Leach introduced Finance Director David Glasser and NBS consultant Tim Seifert.

Seifert reviewed the current revenue sources including taxes and assessment districts, and discussed possible funding sources for the City including the option of a parcel tax, general tax, or an assessment district.

Creation of an assessment district requires analysis to identify metrics to establish a formula to apportion the tax to parcels. Establishing an assessment for parks would require a significant amount of analysis to determine benefits, and an assessment district for streets and/or sidewalks would require much more analysis. In addition, the calculated "general benefit" would need to be paid from another funding source. A general tax can be more straightforward than an assessment district, simply requiring voter approval.

A special assessment vote is conducted via a mailed ballot to property owners, with returned votes tabulated during a public hearing. A majority protest is required to defeat the establishment of an assessment district. The primary cost for establishing an assessment district involves the analysis and calculation of the assessment, as well as mailing ballots.

Finance Director David Glasser reviewed findings of a field poll conducted by The California Endowment regarding soda taxes. Poll results demonstrate support for this type of tax, and possibly a 2/3 approval support. The City of Berkeley utilizes a consultant to administer collection of their soda tax. A public opinion survey was conducted in Albany in 2012 in advance of the ½ cent sales tax ballot measure (Measure F) to identify public priorities. The City's User Utility Tax is near the median in comparison with surrounding cities.

The following people spoke: Preston Jordan, Albany Strollers & Rollers; Ken McCroskey, Albany Strollers & Rollers; Ellen Hershey.

A summary of comments is as follows: the history of voter approved measures in the City demonstrates that special taxes have been approved in the past, and competing measures should not impact the passage of a tax, encouraged a dedicated funding source for sidewalk repair and maintenance, expressed support for a community facilities district; Strollers & Rollers support a dedicated funding source for sidewalk repair and maintenance.

A summary of Council comments is as follows:

Interest in the possibility of a low income exemption option; interest in a parcel tax, and interest in a formula that considers parcel size; suggested leveraging funds with the City and the property owner splitting the cost of sidewalk repair; staff is currently at capacity in implementing capital improvement projects, and any tax measures should be intended for the 2018 ballot, the school bond measures in June will impact voters support for additional taxes, support for a majority approval general tax; concern with 100% payment for sidewalks, examine a sidewalk policy like Berkeley such as 50/50 split; the City should have

the ability to place a tax measure on the ballot regardless of school district ballot measures; support for funding a measure for sidewalks, streets and park maintenance; support for a general tax; a parcel tax will generate more funds than a general tax and is likely what is needed due to funding needs; the City's Advisory Bodies should be informed that the Council is considering a tax for the 2016 ballot as it could impact inclusion of other measures on the ballot.

The Council requested staff bring back to Council pro/con analysis of 3 different revenue options: a large parcel tax which would bring in a similar in language to the current sales tax; a smaller parcel tax limited to sidewalk repairs; and a general tax such an increase in the Users Utility Tax.
