RESOLUTION NO. 2016-38

**A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE CITY MANAGER TO RENEW THE CONTRACT WITH BERKELEY FOOD AND HOUSING PROJECT AT A COST NOT TO EXCEED \$106,000 TO CONTINUE SERVICES FOR PROJECT HOPE FOR A PERIOD OF TWELVE MONTHS BETWEEN JULY 1, 2016 THROUGH JUNE 30, 2017 AND APPROVE \$25,000 TO BE USED FOR THE ALBANY HOUSING SUBSIDY PROGRAM.**

**WHEREAS,** on June 17, 2013, the City entered into a Professional Service Agreement for a Homeless Outreach and Engagement program with Berkeley Food and Housing Project (BFHP); and

**WHEREAS,** the current contract with BFHP is up for renewal at the end of the fiscal year; and

**WHEREAS,** after providing outreach, housing placement and housing retention to chronically homeless residents in the City of Albany for the past three years, BFHP has developed a service intensive model that is a best practice; and

**WHEREAS,** Project HOPE will be staffed by one full time case manager and one part-time housing specialist that will continue to provide outreach and engagement, case management, housing search/landlord relationship development, housing placement, and housing stabilization and retention services; and

**WHEREAS,** BFHP has met and continues to meet and exceed contract goals; and

**WHEREAS,** there is a need for ongoing subsidies in the amount of \$25,000.00 for Project HOPE clients over the next 12 months.

1           **NOW, THEREFORE, BE IT RESOLVED**, that the Albany City Council hereby  
2 authorize the City Manager to renew the contract at a cost not to exceed \$106,000 with  
3 Berkeley Food and Housing Project to continue services for Project Hope for a period of  
4 twelve months between July 1, 2016 through June 30, 2017.

6           **BE IT FURTHER RESOLVED**, that the Albany City Council approve \$25,000 to  
7 be used for the Albany Housing Subsidy Program.
