1. CALL TO ORDER

5. PRESENTATION

5-1. Report from Community Development Department on Active Planning and Building Permit Applications

Community Development Director Jeff Bond discussed current planning and building permit applications, status of the Department, and upcoming actions intended to improve the permit process moving forward. The Department has hired another staff member to provide assistance to the counter, and plan checks will be outsourced to plan review companies that have been retained by the City. Additionally, the Department is implementing an electronic permitting system.

6-1. Staff update: Advisory Body Appointment Term; Holiday Lights Project; Economic Development Strategic Plan
