Police Chief McQuiston reported that he did not believe a representative of the City had directly contacted the City's representative to the East Bay Municipal Utility District.

Mayor McQuaid noted that Mayor Cutter of San Leandro, as the Mayors Conference representative on the Board, recommended the Mayors send the letter to the Board.

The following person spoke: Brian Beall.

A summary of comments is as follows: asked for more information about the Smoking Ordinance updates.

City Manager Crumpley advised that the ordinance further restricts where people can smoke in multiunit buildings and also includes a definition for vaping.

5-1. Council Member Maass Report– February 2017

Vice Mayor Pilch reported that he attended the second meeting of the East Bay Community Energy (EBCE) Board of Directors. The plan likely would not be implemented until spring 2018.

6. PRESENTATION

6-1. Current City Practices and Policies Concerning the Enforcement of Immigration Violations and the Investigation of Hate Incidents

Police Chief McQuiston provided a presentation regarding current City practices and policies concerning the enforcement of immigration violations and the investigation of hate incidents. Albany Police Department (APD) made a public statement and posted policies on hate crime and immigration violations on the City's website. APD uses the services of Lexipol to develop policies. APD's policies meet or exceed the provisions of California law. Officers receive training in identifying and investigating incidents and crimes that may be motivated by hatred or other bias. Per APD policy, APD is prohibited from contacting, detaining, or arresting someone based solely on the suspicion that an individual is an undocumented alien. APD policies reflect the language used in State law. Under current policy, if Immigration and Customs Enforcement (ICE) or any other federal agency made a specific request for assistance, APD would provide available support services such as traffic control or peacekeeping efforts. This is similar to any other agency request for assistance by APD.

Changes to current policy language are being considered regarding the requirement that APD shall provide notification to ICE when a felony arrest is made. City prisoners are housed in Alameda County as administered by the Alameda County Sheriff's Office. Detention of an individual by a member of APD should be based upon the reasonable belief that the individual was involved in criminal activity. Police training and professional development includes procedural justice, fair and impartial policing, and crisis intervention. APD utilizes modern policing and is committed to a philosophy of community-oriented policing.

Mayor McQuaid advised that sanctuary city status was not an agenda item but would likely be on a future agenda. She and City Manager Crumpley will be attending a conference on sanctuary city status.

The following people spoke: Bruce Fukuji, Bonnie Wolf, Hanako Asakura, Rev. Kristin Grassel-Schmidt, Letitia Berlin, Brian Beall, Kathy Rai, Oz Ayduk, Brigid Acuna, Marie Hopper, Bonnie Simms, Teri Hudson, and Frederick Simms.

A summary of comments is as follows: appreciation for the Police Chief's statement regarding policing strategies and concurrence with updating the Police Department manual as soon as possible; support for the Police Department's policies; suggested revisions to Section 428.3.7; support for the poor and oppressed; a request to agendize sanctuary city status soon; the effect of Alameda County Sheriff's Department policies on Albany Police Department's policies; a request for guidelines for community members removing graffiti; support for no APD cooperation with ICE; and a suggestion for APD to work with the Albany Unified School District to ensure schools have a safe and secure atmosphere.

Police Chief McQuiston stated the Alameda County Sheriff Department's policy was not to honor ICE detainers, which aligned with APD policies. From November 2014 to November 2016, no hate crimes were reported. APD is working on a process to temporarily cover graffiti until Public Works crews can remove it.

A summary of Council comments is as follows: interest in amending policies; interpretation of immigration law provided flexibility in policies, whether sanctuary state status would apply to all municipalities in the state; tracking of hate crime incidents; the Federal government arbitrarily withholding funds is not legal; no formal legal definition of sanctuary city; interest in the Social and Economic Justice Commission studying policies and sanctuary city status; Alameda County obtained a grant to help create a network for rapid defense and assistance to families that are threatened; request for ongoing updates on Federal policy changes.

City Manager Crumpley advised that the Strategic Plan now included fiscal years in which projects would occur, advisory body responsibilities, and substantive changes requested at the Council's last review.

A summary of comments is as follows: support for strong requirements to retrofitting soft stories, include existing tax measures in Section 2.1 B; change the voting method for City Council and School Board; and include planning of the next phases of Pierce Street Park construction.

A summary of Council comments is as follows: add "investigate potential sanctuary city policies and programs" in Item 2.2 A.2; the Strategic Plan included Mr. Jordan's comments with the exception of the voting method; the City had no funds or capacity to add anything for Pierce Street Park, and Phase I construction of Pierce Street Park would begin in March and finish by the end of summer.
