**A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING
THE CITY MANAGER TO RENEW THE CONTRACT WITH
BERKELEY FOOD AND HOUSING PROJECT AT A COST NOT TO
EXCEED \$119,570 TO CONTINUE SERVICES FOR PROJECT HOPE
FOR A PERIOD OF TWELVE MONTHS BETWEEN JULY 1, 2017
THROUGH JUNE 30, 2018 AND APPROVE \$15,000 TO BE USED FOR
THE ALBANY HOUSING SUBSIDY PROGRAM**

WHEREAS, Berkeley Food and Housing Project (BFHP) has been providing homeless outreach, engagement, case management and housing services to chronically homeless residents in the City of Albany since July 2013; and

WHEREAS, BFHP was chosen for their extensive experience providing services to people experiencing homelessness since 1970; and

WHEREAS, BFHP has developed a service intensive model that is a best practice using Housing First and Harm Reduction principles in combination with intensive and responsive case management services and been able to house and retain housing for people no-one thought could be housed; and

WHEREAS, Project HOPE will be staffed by one full-time case manager and one part-time housing specialist that will continue to provide outreach and engagement, case management, housing search/landlord relationship development, housing placement, and housing stabilization and retention services; and


WHEREAS, BFHP continues to meet and exceed contract goals; and

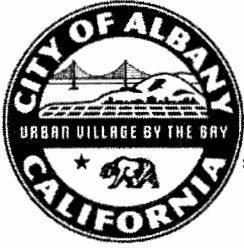
WHEREAS, there is a need for ongoing subsidies in the amount of \$15,000 for Project HOPE clients over the next twelve months.
