A RESOLUTION OF THE ALBANY CITY COUNCIL CONFIRMING THE DIAGRAM AND ASSESSMENT AND LEVYING ASSESSMENTS IN LANDSCAPING AND LIGHTING ASSESSMENT DISTRICT NO. 1988-1 FOR FISCAL YEAR 2017/18

(Pursuant to the Landscaping and Lighting Act of 1972)

WHEREAS, on April 7, 2014, pursuant to Chapter 3 of the Landscaping and Lighting Act of 1972 (Streets and Highways Code Section 22620), the Council approved Resolutions No. 2014-33 and No. 2014-34 directing NBS to prepare the annual reports, for three consecutive years, concerning the levy and collection of assessments within the assessment districts for LLAD No. 1988-1 and 1996-1; and

WHEREAS, on May 15, 2017 the Council adopted Resolutions #2017-31 initiating proceedings, Resolutions No. 2017-33 preliminarily approving the Engineer's Report for FY 2016/17, and Resolution No. 2017- 35 declaring the Intention of the Council to levy and collect assessments, and setting June 19, 2017 as the date for the public hearing for each District in the meeting place of the City Council, 1000 San Pablo Avenue, Albany, CA; and

WHEREAS, in the report of the Engineer, assessments are not proposed to increase over the amount for the previous year; and

WHEREAS, notice of the hearing was given in the time and manner required by law; and



BE IT FURTHER RESOLVED that the City Clerk is authorized and directed to immediately file the Engineer's Report for Assessment District No. 1988-1 for the 2017/18 fiscal year together with a certified copy of this resolution with the Alameda County Auditor.
