

RESOLUTION NO. 2017-76

A RESOLUTION OF THE ALBANY CITY COUNCIL TO AMEND CIP PROJECT NO. 21000 – FY 2016-2020 ANNUAL STREET REHABILITATION PROJECT TO INCLUDE A PROJECT FUNDED BY SENATE BILL1, THE ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017

WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and Signed into law by the Governor in April 2017 in order to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB 1 includes accountability and transparency provisions that will ensure the residents of our City are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and

WHEREAS, the City must include a list of all projects proposed to receive funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1, in the City budget, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

WHEREAS, the City will receive an estimated \$106,000 in RMRA funding in Fiscal Year 17/18 from SB 1; and

WHEREAS, the City has selected to rehabilitate a segment of Evelyn Street from Garfield Avenue to Portland Avenue using the RMRA funding; and


WHEREAS, the SB 1 guidelines require an amendment to the City FY 2016-2020 Capital Improvement Plan to include the rehabilitation of Evelyn Street in Project No. 21000, Annual Street Rehabilitation using RMRA funding; and

WHEREAS, the SB 1 project list and overall investment in our local streets and roads infrastructure with a focus on basic road maintenance and safety will have significant positive co-benefits statewide.

NOW, THEREFORE, BE IT RESOLVED, that the Albany City Council hereby adopt this resolution amending Project No. 21000, Annual Street Rehabilitation included in the FY 2016-2020 Capital Improvement Plan to include the rehabilitation of Evelyn Street from Garfield Avenue to Portland Avenue and funded with RMRA revenues projected at \$106,000 in FY 17-18; and

BE IT FURTHER RESOLVED, that the Albany City Council authorize staff to submit to the CTC the required documents and project list to qualify for funding.
