## A RESOLUTION OF THE ALBANY CITY COUNCIL TO APPROVE PARK HOURS FOR PEGGY THOMSEN PIERCE STREET PARK

**WHEREAS**, the Parks and Recreation Commission discussed hours of operation for Peggy Thomsen Pierce Street Park, Albany's newest public park; and

WHEREAS, the Parks and Recreation Master Plan categorizes Peggy Thomsen Pierce Street Park as a neighborhood park. Neighborhood parks are defined as a combination playground and park, designed primarily for non-supervised, non-organized recreation activities. Typically, facilities found in a neighborhood park include a children's playground, picnic areas, trails, open grass areas for passive use, outdoor basketball courts and multi-use sport fields; and

WHEREAS, the Parks and Recreation Commission took into consideration the current park hours of operation for the City's two other neighborhood parks, Terrace Park, Dartmouth Tot Lot; and

WHEREAS, the Parks and Recreation Commission recommends Peggy Thomsen Pierce Street Park have hours of operation that coincide with the City's two other neighborhood parks; and

**WHEREAS,** Albany Municipal Code 8-4.3 c. states that the City Council, by resolution or ordinance, may set hours of operation at other City park, recreational or open space areas.

NOW, THEREFORE, BE IT RESOLVED, that the hours for Peggy Thomsen Pierce Street Park shall be 7 am-9 pm (April 1-October 31); 7 am-8 pm (November 1-March 31), and that no person shall use, remain in or enter into Peggy Thomsen Pierce

2	7:00am November 1 through March 31.
