Albany Hill cross, easement background

This is something I took time to write on NextDoor a few weeks ago and wanted to share with the city to help ensure everyone is up to speed with the history and chronology of the hill according to court documents. I think it is useful in discussions of the cross and in particular in thinking about what the easement actually says (the easement grants no ownership) and its legitimacy. I'm no lawyer but I summarized here what I read in the documents. My only modifications from the original NextDoor post are to remove the guy's name I was responding to and to add a "*" and a P.S. and P.P.S. at the bottom. -Bryan Marten

I wanted to correct a central falsehood and misconception in your posts that may be confusing to some people.

You say

- "This Cross is standing on a land donated by a former Mayor of ACC and the Cross too was donated by him."
- "...he should be honored and thanked for giving up his own land for the benifit of us all."
- "Thank you former Mayor for donating /gifting your land for the benifit of the citizens of Albany."

We can see the following facts from the California State Supreme Court ruling against the former mayor Mr. Call. My statement below is a summary. Anyone is free to read the document for themselves to find these facts in the top portion of the document.

Mr. Call, a Lion, did not donate the land to the city. While he was mayor, in 1970 he bought the land at the top of the hill for under \$63,800* at about the same time a huge development was being planned down the hill by the freeway where large condos and apartments are now. In 1971 Mr. Call's Lions organization erected the cross where it stands now. He and the city then worked out a multi-part deal to allow the developer to move ahead with the huge development down-hill (it required a zoning change) but only if Mr. Call could be *paid* for his few acres of land at the top of the hill and if the land could then be transferred to the city as a public park. The developer agreed to this, originally offering Mr. Call its appraised value of \$63,800 stating that the land must not contain any easements or other encumbrances that would diminish the value of the land. In the end, Mr. Call bargained the developer up to \$258,000 which is how much he was paid for the land (minus fees) while mayor. Shortly before the deal closed, Mr. Call insisted upon burdening the parcel of land with the easement granting the Lions no land and no ownership of the cross but access to it "for ingress and egress to maintain the existing cross." Having any kind of easement actually diminished the value of the land but the real estate developer went through with the deal anyway because the developer did not care because the developer knew it was going to follow through with the multi-part agreement by promptly donating the land, burdened with Mr. Call's easement, to the city. As the court documents reveal, it appears the city was deceived in accepting the easement to maintain the cross because "There is no evidence that the members of the council, other than Call, knew that the Calls' 1.1-acre parcel was being accepted by the city subject to the easement for maintenance of the cross." Due to the conflict of interest, the court ruled against Mr. Call, ordering him to pay the city all \$258,000 (plus interest, minus fees) he had gained and to forfeit the land.

So yes the city did get the land for free but it was donated by a developer who, as part of a multi-part deal, had paid Mr. Call many times what Mr. Call had bought the land for just a year or 2 before. And yes there is a easement on access to the cross but it grants no property rights other than access and was added last-minute without the knowledge of the city. I myself wonder what kind of person tries to preserve a newly-erected lit cross on land knowing it will become part of a public park?

I would note that from the Friends of Albany Hill website https://friendsofalbanyhill.org

we can see a personal statement from one of the 9 Albany residents who were part of the lawsuit brought against Mr. Call for his conflict of interest. We get a peek into the kind of person Mr. Call was by seeing he counter-sued these 9 Albany residents for damages of \$1 million each. Quoting from the website here: According to Thelma Rubin, an original member as well as a former Albany city council member and mayor, Friends of Albany Hill seems to have started in 1974, when nine residents (including Thelma Rubin, Dario Meniketti, and Catherine Webb) of Albany Hill brought a lawsuit against the city of Albany, councilman Hubert Red Call and his wife Ruth Call, four other council members, and a development company, Interstate General Development Corporation. Councilman Call had sold 1.1 acres of his Albany Hill land to IGD for \$258,000, and IGD then donated the land to the city. The citizens alleged the land Call sold to IGD was overpriced and the transaction was a conflict of interest, since Call was an elected official. IGD was building the Gateview condominium towers on the west side of the hill at the time.

Peter Taussig, a lawyer who lived on Albany Hill, handled the case pro-bono, with Friends of Albany Hill paying legal fees. The suit went through many courts and IGD and Call filed counter-suits against the city and the nine plaintiffs. Rubin recalled that, although she was being sued for one million dollars, she and her husband were still able to receive a car loan they applied for.

In 1985 the California Supreme Court ruled in favor of the nine citizens and ordered Call to pay the city the amount he received from the sale of his land plus interest.

Mr. Call eventually did hard time in a state prison for selling stolen goods. As Rochelle pointed out in a different post, he was sentenced to state prison for a six-month-to-five year term - not for the cross shenanigans, but for fencing jewelry out of his shop on San Pablo Avenue ("City Councilman Sentenced, The Argus, April 13, 1976)"

This is the person you and some in the Lions Club are saying we should honor and thank and preserve his legacy of a lit cross overlooking the East Bay.

One last item I would like to briefly address. You say:

"Wouldn't that be a nice tradition to start rather than spending tax payer money on litigation? Think about it." I would state the obvious that the only reason the city would spend taxpayer money on litigation here would be if the Lions Club files a lawsuit. The Lions Club is a service organization whose own Bylaws and Constitution say not to even debate sectarian religion yet here we are with a Lions Club group forcing evangelical Christianity on the residents of Albany while several (most?) of its officers are not Albany residents. As a non-profit, public records show it is not even incorporated in Albany. Some of its members are Albany residents so in that sense it represents Albany but one could say the same of the East Bay Atheists who we should actually honor and thank for bringing to the public's and the city's attention the fire hazard represented by the way the cross, until last week, used a eucalyptus tree for a power pole (!!!) in what the city had long before deemed a "Critical Fire Area".

Other Lions Clubs like the one in La Crescent, Minnesota last year, have worked with their city councils to remove a cross from public land. I would hope and trust that the Albany Lions could show the residents of Albany how a respected service organization can handle a situaion like this.

*The documents I see don't say how much Mr. Call bought the 1.1 acres for but they say he bought it for less than the lowest appraised value prior to the land deal with the developer and \$63,800 is the lowest appraised value. As I say above, a year or 2 later he then sold it for \$258,000. That was the crux of the case against him.

P.S. An elderly neighbor down the street from me who was born in Albany and is a long-time resident told me today he remembers Mr. Call and his jewelry shop and that while mayor, Mr. Call flew to Hawaii to wine and dine the elderly man (97 yrs of age as the story goes) who owned the top of the hill so Call could buy the 1.1

acres for a song, knowing the Pierce St. development was being planned. I have nothing to back this up but it seems consistent with the rest of Call's actions.

P.P.S. Here is the blurb in The Argus newspaper from 1976 about Mr. Call being sentenced to state prison. https://www.newspapers.com/newspage/38004391/

The article can be seen in that grainy image. An image-to-text version found on that same web page (with some minor error correction on my part) says this:

Albany councilman sentenced OAKLAND (UPI) Albany city councilman Hubert F. Call, 57, yesterday was sentenced to state prison for six months to five years for attempting to receive stolen jewelry from an undercover police agent. Superior Court Judge Hugh S. Koford also fined Call \$15,000. Execution of the sentence was stayed until June to make a determination of an announced appeal by Call's attorney, Martin MacInris. Madiris charged the case was a contrived one and that the jewelry involved were never stolen but were seized by the Customs Service in a smuggling case. Call, a jewelry store owner, contended he was attempting to recover his wife's jewels which were stolen after a banquet and thought he was dealing with underworld figures attempting to resell his wife's jewels to him.

I took the dog up the hill to check out the cross for myself this afternoon and discovered PG&E has finished the job and it is *much* safer. Maybe even completely up to code, minus concerns about the cross itself falling over (which is still a concern due to the erosion at its concrete base and the haphazard welds holding the plate to the concrete).

The wire used to be connected at the street at a pole and then threaded through eucalyptus trees (attached to one!) to eventually get to the cross. And maybe PG&E said its original plan was to improve safety by merely fortifying the wire but what I saw today they *actually* did is to make a new connection at the street mid-way between 2 poles (see attached photo) with a straight shot to the cross with no extra support. That is a shorter distance than it was before to the pole because it's almost straight perpendicular from the line. I checked where the line to the cross sags and it is pretty low to the ground but not reachable by me so it may meet code but I don't know. I don't know how long the wire is - its unsupported length may or may not be up to code.

In any event, the East Bay Atheists and the city and all who expressed concern about the fire safety represented by having for decades an electrical service using a eucalyptus tree as a pole in a Critical Fire Area (!!!) appear to have caused a huge change for the better for the residents and city of Albany. There may still be issues with the safety of the cross structurally or with the new electrical service distance or height. That should be looked in to by someone knowledgeable in electrical and structural codes but those who have been involved with this effort should know that they have helped make the situation *much* better than it was.

There are also of course serious concerns the council and I and others have expressed with how the cross in the public park goes against the city's statement of inclusion. Those still need to be addressed.

Attached are the photos I took up at the cross. The photo DSC_0492.JPG I took a few months ago showing zoomed in where the wire used to connect to the street at a pole so you can see the difference. The other 4 photos are from today with the new connections.

I am very concerned about the city's handling of the dispute regarding the cross on Albany hill. I am a Christian citizen of Albany with no strong feelings about the cross itself, but I feel that the way the city is handling this is to the detriment of all the citizens. By claiming the cross needs to be removed in the name of tolerance is in itself an act of intolerance. Claiming the religiously diverse citizenry is not an excuse. Having talked to muslim and Buddhist friends of mine no-one feels threatened by the cross, no-one feels their religious freedom is hampered. Indeed when looking at the complaints it is only the Atheists, exactly the people who claim no religion who feel unhappy about the existence of the cross. I am very concerned when I look at the current political events in the US where a strong backlash against actions claimed to be motivated by tolerance towards minorities but feel like intolerance towards the majority have brought truly intolerant people into power. By acting in exactly the same way you risk alienating many of the people who have quietly enjoyed the cross over the decades, while there may only be a handful of atheist activists who actually feel strongly about removing the cross. If you feel that the non-christian Religions need an opportunity for worship I would be very surprised if the Lions club (or anyone else) would object to use of public lands for worship that does not involve removing the cross. From reading the correspondence from both parties (not having been at all the relevant city council meetings) I can only conclude that the safety concerns have been pushed forward was a pretense to remove power, without asking PG&E about their opinion or giving the Lions Club a specific list of issues they need to fix. If this was truly a safety concern, would you have shut down power to a residence under the same circumstances? I really hope this fight does not go any further.

I am deeply dismayed about the time, effort and money this has already wasted.

Dear city council,

I posted a message on NextDoor.com a few weeks back in a discussion thread about the cross on Albany Hill. Here's what I said then:

I live at the base of the hill, and I'm a Christian pastor. I'd love to see the cross go: it bothers me every time I walk through the park. I treasure our pluralistic society and I don't want symbols of my faith imposed on all of us. Not only is it unfair to non-Christians, it harms Christians as well by associating our faith with a kind of triumphalism that at best seeks to dominate the public space and at worst is associated with horrific violence (see Rochelle's other post). I can pray before a cross any time at church: I don't need or want one in a public park. Following Jesus is about living out the good news of God's love, not sticking Christian symbols in other people's faces.

I recently got a note from Bryan Marten, another Albany resident, encouraging me to get in touch with you, and it seemed like a good idea--so I'm reaching out to ask whether I can be helpful to you in any way as you continue to consider how to proceed. I hope you'll maintain your position seeking to find an amicable resolution that replaces the cross with something more appropriate to a public park.

I'm an Episcopal priest, working on a Ph.D. at the Graduate Theological Union in Berkeley and living at 943 Jackson Street in Albany. I know a number of other progressive Christians in the area, including several other Albany residents, who I think would share a similar perspective.

Thanks for all the work you do on behalf of our community.

I'm a night owl, and most nights I walk around the area, usually around Albany Hill. I'm getting really annoyed by the automated flood lights that are so common around here; they're startling and some are quite painful on my dark-adapted eyes.
