

1 **WHEREAS**, an appointment under Government Code section 21221(h) requires an active,
2 publicly posted recruitment for a permanent replacement; and

4 **WHEREAS**, the current status of this recruitment is active; and
5

6 **WHEREAS**, this section 21221(h) appointment shall only be made once and therefore will
7 end on June 30, 2018; and
8

9 **WHEREAS**, the entire employment agreement, contract or appointment document
10 between Darla Majors and the City of Albany has been reviewed by this body and is attached
11 herein; and

13 **WHEREAS**, no matters, issues, terms or conditions related to this employment and
14 appointment have been or will be placed on a consent calendar; and

16 **WHEREAS**, the employment shall be limited to 960 hours per fiscal year; and


18 **WHEREAS**, the compensation paid to retirees cannot be less than the minimum nor
19 exceed the maximum monthly base salary paid to other employees performing comparable
20 duties, divided by 173.333 to equal the hourly rate; and

22 **WHEREAS**, the maximum base salary for this position is \$6,908.00 and the hourly
23 equivalent is \$39.8539, and the minimum base salary for this position is \$5,155.00 and the
24 hourly equivalent is \$29.7404; and

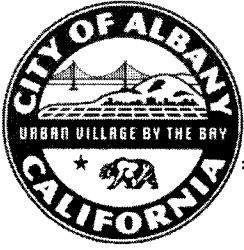
26 **WHEREAS**, the hourly rate paid to Darla Majors will be \$39.8538; and

7 agreement / contract / appointment document and that this appointment is necessary to fill the
8 critically needed position of Communications Clerk (Public Safety Dispatcher) for the City of
9 Albany by January 1, 2018 because this position is critical to the daily operations of the Albany
10 Police Department Public Safety Dispatch Center and Public Safety Answering Point while the
11 City of Albany recruits to fill the position on a permanent basis.
