**7-1.** City Council Subcommittee regarding Albany Waterfront Memorandum: Next Steps on the Albany Bulb and Buchanan Right of Way

Mayor McQuaid & Vice Mayor Nason recommendation: that the City Council defer the selection of a consultant to prepare the CEQA document for the planned transition of the Albany Neck and Bulb to the East Bay Regional Park District (EBRPD), as discussed in the Albany Neck and Bulb Transition Study (the Study). Such a deferral will accommodate the need to meet and confer with the EBRPD regarding information requests, and potential refinements to the city's Memorandum of Understanding (MOU) with that agency, as set forth in the attached e-mail message from City Manager Nicole Almaguer to EBRPD's Assistant General Manager Robert Nisbet.

It is also recommended that the Council designate the \$300,000 that it has budgeted for the Bulb CEQA document in the current fiscal year as a Council discretionary fund for the Bulb. The Subcommittee will work with staff to prepare parameters for the use of these funds that can be incorporated into the FY 18/19 budget for Council review. This fund may be rolled over by the Council from year to year until needed for preparation of a CEQA document or documents, and/or to implement public safety, water quality, or other environmental protection expenditures for the Bulb that are either exempt from CEQA or otherwise do not require the preparation of an EIR.
