**A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE
CITY MANAGER TO ENTER INTO A THREE-YEAR AGREEMENT WITH
EVOLVE IP FOR DISASTER RECOVERY SERVICE**

WHEREAS, the City does not currently have a disaster recovery solution in place for data and applications stored on the City's network servers; and

WHEREAS, the lack of a Disaster Recovery Site for the City's network servers could cause delayed business resumption after a disaster; and


WHEREAS, staff reviewed proposals from three recommended vendors that provide disaster recovery services; and

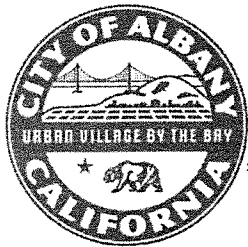
WHEREAS, Evolve IP has been identified from proposals submitted as the most competitive service provider.

NOW, THEREFORE, BE IT RESOLVED, that the Albany City Council authorizes the waiver of formal bids and authorizes the City Manager to enter into a three-year agreement with Evolve IP for the Disaster Recovery Service Project for an amount not to exceed \$189,000.

BE IT FURTHER RESOLVED, that the Albany City Council approves the funding of this project cost appropriated as follows:

1. FY 18/19 Budget: transfer \$69,000 from Information Services, Equipment Reserve Fund (Dept. 16, Fund 2201) to Information Services, General Operating Fund (Dept. 16, Fund 0001).
2. FY 19/20 Budget: transfer \$60,000 from Information Services, Equipment Reserve Fund (Dept. 16, Fund 2201) to Information Services, General Operating Fund (Dept. 16, Fund 0001).
3. FY 21/22 Budget: transfer \$60,000 from Information Services, Equipment Reserve Fund (Dept. 16, Fund 2201) to Information Services, General Operating Fund (Dept. 16, Fund 0001).
