**A RESOLUTION OF THE ALBANY CITY COUNCIL TO AWARD AND
AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACT C18-
35 FOR PHASE ONE OF THE ANNUAL SIDEWALK REHABILITATION
PROJECT**

WHEREAS, the Citizens of Albany in November 2016 approved Measure P1, a parcel tax for the purposes of funding repairs to the City sidewalks; and

WHEREAS, under Section 5610 of the California Streets and Highways Code and per Albany Municipal Code Section 14-1.5b, property owners and persons in possession of property are required to maintain adjacent public sidewalks in a safe condition; and

WHEREAS, the existence of a tax-funded City sidewalk repair program does not abrogate the responsibility of property owners to maintain their frontage improvements in a safe manner; and

WHEREAS, on March 19, 2018, the City Council authorized staff to issue a Notice Inviting Bids for the Sidewalk Rehabilitation Phase 1 Project; and

WHEREAS, on May 3, 2018, the City received and opened two bids for the above-mentioned project; and


WHEREAS, Villalobos & Associates is the lowest responsible and responsive bidder for the construction of the Sidewalk Rehabilitation Phase 1 Project; and

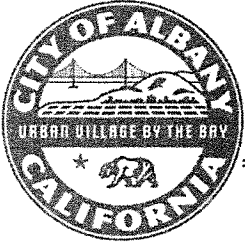
WHEREAS, the budget for CIP No. 22000 – Annual Sidewalk Rehabilitation Project was appropriated by Council as part of the City’s Capital Improvement Program last updated by Resolution No. 2018-36 in March 2018.
