

RESOLUTION NO. 2018-71

A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE CITY MANAGER TO SUBMIT SAN PABLO/BUCHANAN COMPLETE STREETS IMPROVEMENTS FOR FUNDING FROM CYCLE 4 OF THE STATE OF CALIFORNIA ACTIVE TRANSPORTATION PROGRAM

WHEREAS, on April 16, 2012, the City Council adopted Resolution No. 2012-25, adopting the Albany Active Transportation Plan following a two-year community planning process; and

WHEREAS, the Albany Active Transportation Plan identifies the Buchanan/Marin Merge Realignment and the San Pablo Streetscape and Walking Safety Project as high priority projects; and

WHEREAS, on December 16, 2013, the City Council adopted the Complete Streets Study for San Pablo Avenue and Buchanan Street following a twelve-month public planning process to develop a Complete Streets concept design; and

WHEREAS, on July 18, 2016, the City Council adopted Resolution No. 2016-65 awarding a contract for the development of construction plans, specifications, and estimates (PS&E) for the San Pablo Avenue and Buchanan Street Pedestrian Improvements Project; and

WHEREAS, on March 19, 2018, the City Council adopted Resolution No. 2018-36 authorizing the adoption of the FY2018 – FY2022 Five Year Capital Improvement Plan; and

WHEREAS, the Capital Improvement Plan establishes a strategic planning document for capital projects including scoping, scheduling and funding individual projects to be implemented within five years; and

WHEREAS, the Capital Improvement Plan identifies Cycle 4 of the State of California Active Transportation Program as the potential funding source for Project #24001 Complete Streets (San Pablo / Buchanan).

NOW, THEREFORE, BE IT RESOLVED, that the Albany City Council authorizes the City Manager to submit San Pablo/Buchanan Complete Streets Improvements for funding from Cycle 4 of the State of California Active Transportation Program.
