STUDY SESSION: RENT REVIEW ORDINANCE

The Council will hold a study session to review the draft Rent Review Ordinance.

Staff recommendation: that the Council:

- a) Receive an update from staff regarding changes made to draft Ordinance No. 2018-02 based on Council direction from the April 2, 2018 first reading of the ordinance;
- b) Conduct a study session to receive additional input regarding the proposed ordinance; and
- c) Provide direction to staff regarding any next steps associated with the draft ordinance.

City Manager Nicole Almaguer presented the staff report. Staff incorporated changes directed by the Council into the draft ordinance before the Council. The purpose of the study session is to obtain additional public input. Staff revised the draft ordinance to clarify a number of definitions; set the rent review trigger at 5%; clarify good cause with respect to mediation; and to add an application fee for tenants requesting rent review.

Assistant City Manager Isabelle Leduc reported during the implementation period staff will recruit staff; retain conciliation and mediation services; implement an outreach strategy.

A summary of the comments is as follows: the Social and Economic Justice Commission (SEJC) recommends some protection for renters during the 150-day period, referral of just cause to the SEJC, and a lower trigger; reduce the 150-day period and add just cause; clarify the language regarding notification of rent review availability and add condition of the property as a factor considered in mediation; Albany Property Rights Advocates

(APRA) recommends a trial voluntary program; a rent subsidy program would better serve residents; utilize a dollar amount for the trigger and start with a higher trigger; increase the trigger amount; APRA suggests the use of a professional, experienced mediator and a tenant fee high enough to prevent frivolous requests; implement a voluntary program until all residents and property owners are aware of the program and its requirements; a Rent Review Program will not ease the housing crisis; opposition to a Rent Review Program; a limit on rent increases will prevent landlords from making improvements to rental property.

A summary of Council comments is as follows: the possibility of hiring a contractor rather than a staff person; a suggestion to add a "whereas" for the current workshop and to move Section 5.25.4(G) to become Section 5.25.4(E)(5) in the draft ordinance; a Rent Review Program will provide information about Albany rents and rent increases; support for tenants to pay a fee to request review; a rental subsidy program could have merit; support for a different means to encourage participation in mediation given the City Attorney's information about litigation; support for a 7% trigger; a tenant can agree to a rent increase of any amount and not request rent review; the Rent Review Program cannot limit the amount of a rent increase; any provisions of the draft ordinance that could cause litigation should be discussed in closed session.

The Council directed staff to consult with outside counsel and schedule a closed session to discuss the draft ordinance threat of litigation arising out of the Rent Review Ordinance.

City Manager Almaguer reminded members of the public to register for email notification of future meetings regarding rent review.

Mayor McQuaid read the following statement:

The violence that our community experienced a week ago Sunday was deeply disturbing. On behalf of the City of Albany, I want to express my sincere condolences to the family and friends of Raphael Fuentes-Lee as they cope with this tragedy.

The sense of safety and wellbeing of our community is extremely important to me as Mayor and to all of the City Council Members. I was in daily contact with the Chief of Police to receive updates on the status of the investigation, and I was pleased to hear when the arrests were made.

I want to express my thanks to the members of the public who assisted the Police Department in quickly identifying the people allegedly responsible for this crime. I also wish to thank the Albany Police Department for their tireless and professional work to apprehend the suspects.

I realize that some people are frightened and concerned about the safety of their families. A member of our community was murdered in broad daylight in one of our parks. It is unacceptable, and we must all do everything we can to cultivate a safe, caring community environment for Albany. Please keep Raphael Fuentes-Lee and his family in your thoughts as we grieve the loss of one of our community members.

Item 5-15: Council Member Pilch reported staff achieved greater cost savings than those stated in the staff report. Staff utilized a no-bid contract because of the stringent requirements for disaster recovery services provided to cities and fire and police departments.

Items 5-16 and 5-18: Community Development Director Jeff Bond reported City policy directs staff to present requests for waiver of fees to the Council. Fees are charged for each application submitted.

Item 5-10: Mayor McQuaid thanked Sergeant Krebs for 35 years of service to Albany.

A summary of the comments is as follows: more discussion is needed for Item 5-15 as the contract amount appears high and it is a no-bid contract; appreciation for Sergeant Krebs' commitment and service to the community.

7. COUNCIL MEMBER REPORTS ON STATE/REGIONAL/LOCAL MEETINGS ATTENDED AND ANNOUNCEMENT OF FUTURE MEETINGS/CITY MANAGER REPORT/COMMENTS

7-1. Council Member Maass Report

Council Member Maass reported he attended meetings of the Alameda County Waste Management Authority/Energy Council/Recycling Board and the Alameda County Transportation Commission (ACTC). The Alameda County Waste Management Authority adopted positions on relevant legislation, reviewed its budget, and discussed separation of recyclable materials. ACTC discussed positions on legislation and the need for local jurisdictions to expend transportation funds. In response to Council Member Pilch's question regarding local markets for recyclable materials, Council Member Maass advised that the investment amount needed to start a recycling business is usually prohibitive. Paper is toxic to recycle; therefore, paper cannot be recycled in California.

Council Member Pilch reported he attended an East Bay Community Energy meeting, in which the Board directed staff to create a 100% renewable product. He, Vice Mayor Nason, and Mayor McQuaid attended the Police Department swearing-in ceremony.

Vice Mayor Nason reported she attended the Senior Resource Fair and was impressed with the level of participation.

Council Member Barnes reported he met with Planning Department staff to discuss housing opportunities.

Mayor McQuaid reported she attended the Community Leaders meeting, Coffee with a Cop, the Senior Resource Fair, the White Elephant Sale, the Everyone Home Leadership Board meeting, and the Chamber of Commerce mixer. Vice Mayor Nason and she attended the sea level rise event.

City Manager Almaguer reported May is Bike Month. Bike About Town is scheduled for May 18 at 6:30 p.m. The Play Like a Girl event on May 20 promotes girls' sports. Anyone can sign-up to receive the City's e-newsletter on the City's website.

Mayor McQuaid announced applications for the parcel tax exemption renter rebate must be postmarked by June 1. Congresswoman Barbara Lee will host a Town Hall on Monday, May 14, at the Community Center between 7:00 and 8:30 p.m.

8. PRESENTATION

8-1. Public Opinion Survey Presentation

Staff recommendation: that the Council receive a presentation regarding the results of the Public Opinion Survey conducted by Godbe Research regarding possible revenue measures for the November 2018 Election

City Manager Almaguer presented the staff report.

Brian Godbe, Godbe Research, reported the purpose of the survey was to gauge the importance of local issues and to assess voter support for a sales tax extension measure and a parcel tax measure to maintain park and open space facilities. Residents were contacted by landline, cell phone, text message, and email message. The survey was conducted between the end of March and the beginning of April.

Survey results demonstrate a solid base of support for a sales tax measure. Support for a parcel tax measure is slightly lower but achievable. Any public information or independent campaign should focus on both measures and the top tier projects and programs. Godbe Research recommends the City of Albany continue preparing a sales tax measure and a parcel tax measure for the November 2018 election.

City Manager Almaguer advised that the next action will be determining details of a parcel tax.

8-2. Emergency Operations Plan Adoption

Staff recommendation: that the Council adopt Resolution No. 2018-53 approving the 2018 Emergency Operations Plan and authorizing the City Manager to revise any Annexes, Appendices and/or Attachments to the Emergency Operations Plan

Fire Chief Lance Calkins presented the staff report. The 2018 Emergency Operations Plan (EOP) involves all departments in the City and citizens. The EOP will be updated as needed. The EOP defines the scope of preparedness and emergency management activities, assigns responsibilities, sets authorities, describes the protection of the populace, and identifies resources.

Brenna Howell, Howell Consulting, reported the events of 9/11 focused attention on emergency preparedness and operations. The EOP outlines responsibilities and actions during an emergency and during recovery and covers the entire emergency management cycle. The EOP coordinates with the County of Alameda's and the State's emergency plans. The Emergency Operations Center (EOC) Annex describes the coordination of information, resources, and personnel that occurs in

an EOC. The EOC's sharing of information with the public is important. Next steps are training, exercising, and planning for emergency situations.

Chief Calkins related a table-top exercise and a large-scale drill with subsequent review and analysis for potential modifications are planned in the next year.

City Manager Almaguer presented the staff report. Sections 2-16 of the Municipal Code are dated and refer to a Disaster Policy Advisory Group, which does not fit in the current organizational framework for disaster preparedness. Staff added the importance of community engagement and references to the Emergency Operations Plan and deleted references to the Disaster Policy Advisory Group.
