DELINQUENT GARBAGE BILLS**



NOW, THEREFORE, BE IT RESOLVED, that the Albany City Council hereby confirms the report and attached special assessment list associated with delinquent garbage bills.

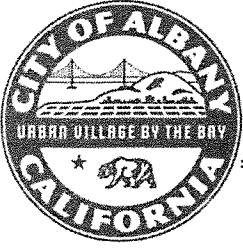
