Mayor McQuaid asked if anyone wished to remove an item from the Consent Calendar. Mayor McQuaid removed Item 5-7, Council Member Maass removed Item 5-5, and Council Member Pilch removed Item 5-6.

Item 5-5: Council Member Maass requested staff consider laying conduit beneath sidewalks to facilitate electric vehicle charging and allowing charging stations to be installed on the planting strip between the sidewalk and the street.

Item 5-6: Council Member Pilch appreciated revisions to the ordinance.

Item 5-7: Public Works Director Mark Hurley reported residents should submit claims for damages caused by contractors during street and sidewalk projects to the City. The City will submit the claims to the contractors, and the claims should be resolved fairly quickly. Staff will issue a Notice to Proceed for the Evelyn Rehabilitation Project later in July. The 2018 Street Resurfacing and Active Transportation Plan (ATP) Project is a combination of base repair and slurry sealing and will provide meaningful improvements before street rehabilitation projects, which include Washington Avenue, begin in early 2019. Staff will plan street rehabilitation projects over the next five years and present them to the Traffic and Safety Commission and the City Council. Signage for street and sidewalk projects will note the use of SB 1 funding for the projects.

Capital Improvement Program (CIP) Manager Robert Gonzales reported staff's strategy is to maintain past improvements and rehabilitate significantly degraded streets. Street projects are currently planned for the area north of Solano Avenue because East Bay Municipal Utility District's (EBMUD) projects are located mainly south of Solano Avenue. The 2018 Street Resurfacing and ATP Project includes resurfacing 16 streets, striping and signing 12 streets, and concrete repairs to curbs and gutters at an estimated cost of \$950,000.

The following persons spoke: Francesco Papalia, Ed Fields. A summary of the comments is as follows: the pavement condition of Washington Avenue is not safe for bicyclists, and repairs should be made before the rainy season begins; an inquiry about the omission of Kains Avenue from the project.

CIP Manager Gonzales explained that the City of Berkeley has sewer work planned for Kains Avenue in the fall, after which the City of Berkeley will reconstruct Kains Avenue to City of Albany standards.

A summary of the comments is as follows: hopes that the Council can make progress on the new affordable housing project and employing a new social worker for the Community Resource Center following the August recess; appreciation for the pedestrian crossing signs installed on San Pablo; the termination of janitors is sad; the new janitorial contractor did not offer former workers overtime or benefits; perhaps the City should look into the situation with the new janitorial contractor; support for the former janitorial workers.

# 7-1. Mayor McQuaid Report

Council Member Maass reported he attended the Programs and Projects Committee of the Alameda County Transportation Commission where he heard project updates and information about a \$105 million technical adjustment to the 2018 Comprehensive Investment Plan. He also attended a meeting of the Recycling Board Planning Committee wherein participants discussed an expansion of the San Leandro ACI plant, changes in rules of procedures, and food service packaging.

Council Member Pilch reported he attended the Chamber Mixer with Council Members Barnes and Maass.

Vice Mayor Nason reported Mayor McQuaid and she attended the Mayors Conference. Vice Mayor Nason also attended the settlement conference in the case of Lions Club versus City of Albany, a barbecue at the Senior Center, and the Independence Day event at Memorial Park. In addition, Vice Mayor Nason spoke at the birthday celebration for the Dalai Lama and met with an Albany Unified School District (AUSD) Board Member regarding ranked choice voting.

Mayor McQuaid reported she attended the opening of the art exhibition at the Community Center, participated in a conference call with Climate Mayors, and attended the District Attorney's Justice Academy. The Recreation and Community Services Department held a wonderful July 4th celebration, which was well attended.

City Manager Nicole Almaguer reported the East Bay Regional Park District is planning a groundbreaking event for the beach restoration project for August 8. The AUSD Board of Education may hold a special meeting on July 20 to discuss the possibility of requesting its removal from the City Charter. Phase I sidewalk repairs have been completed in 22 of 40 locations. The nomination period for City Council and AUSD Board of Education candidates opened July 16 and closes August 10. Residents have registered more than 20 block parties for National Night Out. Staff is purchasing water bottle filling stations with funds from sugar-sweetened beverage tax revenues and anticipates installation in early fall.

# 10-1. Contract for School Crossing Guard Services

Staff recommendation: that the Council adopt Resolution No. 2018-100, authorizing the City Manager to enter into a contract with All City Management Services to provide crossing guard services for the 2018/2019 school year in an amount not to exceed \$124,076 for six crossing guards

Police Chief John Geissberger presented the staff report. Prior to negotiating a contract with All City Management Services as directed by Council, staff notified and met twice with Service Employees International Union (SEIU) regarding the contracting of crossing guard services. While SEIU wanted the crossing guard program to remain in-house, it had no proposals for addressing coverage issues.

Under the proposed contract, All City Management Services will employ six crossing guards for elementary school children. Contract provisions will require All City Management Services to handle all aspects of the program. Current

crossing guards who meet All City Management Services' hiring guidelines will undergo orientation and training and be offered employment and will be paid an hourly rate higher than the current City rate. All City Management Services is a sole-source vendor according to Albany City Council Administrative Policies and as such is exempt from the bidding process.

Contracting with All City Management Services will benefit the City by providing professional management, extensive experience, and crossing guard training and certification; reducing the City's liability risk; relieving the City of personnel and program administrative duties; and guaranteeing coverage for all crossing sites without the use of Police personnel. Other cities have been very satisfied with the services provided by All City Management Services and its coverage of personnel absences.

Sugar-sweetened beverage tax revenues will fund the contract for the 2018-2019 school year. The Council will have the opportunity to review the contract within one year.

The following persons spoke: Jeremiah, Julio Corral, Brian Parsley. A summary of comments is as follows: disappointment with the higher cost of the contract, the loss of City jobs, and use of sugar-sweetened beverage tax revenues; SEIU requests the City not contract crossing guard services, utilize funds to increase the pay for current crossing guards, and meet with SEIU representatives again; support for approval of the contract.

A summary of Council comments is as follows: the cost of contracting services will not be significantly higher due to the City's total cost not including indirect and programmatic costs; the Council has considered the situation carefully and does not make its decision lightly; reluctant support for the contract because of the use of sugar-sweetened beverage tax revenues, the potential use of police officers in emergency situations, and the loss of union jobs.

**10-2.** Calling for a General Municipal Election and Requesting Consolidation with the Statewide General Election

Staff recommendation: that the Council:

- Adopt Resolution No. 2018-98 A Resolution of the Albany City Council Calling and Giving Notice of Holding a General Election to be Held November 6, 2018 and Requesting the Board of Supervisors of Alameda County to Consolidate Said Election with the Statewide General Election; Authorizing the City Clerk or Her Duly Authorized Officers to Carry Out All Necessary Procedures for Said Election; and Submitting to the Voters Three Ballot Measures; and
- 2. Assign a Council subcommittee or subcommittees to prepare written arguments for the ballot measures as identified in Resolution No. 2018-98

City Clerk Anne Hsu presented the staff report. Ballot measures for an extension of the half-cent sales tax, a special parcel tax to replace the existing Measure R assessment, and a Charter amendment to transition the City Treasurer from an elected to an appointed position have been proposed. Staff recommends the Council identify Council subcommittees to prepare arguments in support of the ballot measures. The Council may form one subcommittee for each ballot measure or one subcommittee for all three ballot measures.

City Manager Almaguer clarified that the assessment structure of Option C, presented in the July 2 Council meeting, most closely matches the existing assessment structure of Landscape Lighting Assessment District (LLAD) 96-1. The amounts are not exactly the same for each land use because one is a parcel tax and one is an assessment based on specific usage of the property. Staff revised the ordinance to indicate the parcel tax will be ongoing and revised the Charter amendment to reflect a date of December 10, 2020.
