

SUSTAINABILITY COMMITTEE REGULAR MEETING MINUTES

1. CALL TO ORDER

The meeting was called to order by Chair Peterson at 7:31pm.

5-1. Sustainability Events

Claire Griffing provided an update on upcoming City sustainability events.

5-2. Climate Mitigation & Adaptation Plan RFP Update

Chelsea Polevy provided an update – City staff is in the process of reviewing project proposals and will choose four firms to interview in the next few weeks. Chair Peterson and Committee Member Ohshita will participate on the interview panel.

6. DISCUSSIONS AND POSSIBLE ACTION ON MATTERS RELATED TO THE FOLLOWING ITEMS:

6-1. East Bay Community Energy Update

Griffing provided an update – the Council meeting on May 21 will include a discussion of opting up all residential customers to East Bay Community Energy's Brilliant 100 (100% carbon-free) product when the program launches to residential accounts in November. Staff and the sustainability committee have recommended that Council do so. The program will launch to commercial customers in July.

6-2. Energy Efficiency Subcommittee Update & Discussion of Home Energy Program Priorities and Options

Committee Member Wei presented an analysis of the City's Home Energy Score Pilot Program results, explaining that the audits are geared towards insulation and heating and that electricity savings are minimal. The Committee determined that retrofits would be costly with minimal payback. Vice Chair Smithies suggested that staff bring back the energy policy analysis that was not discussed at the April meeting.

6-3. Outreach Subcommittee Update

Committee Member Cooper provided an update – he attended a meeting for Albany Climate Action Coalition (ACAC), a community organization that is advocating for East Bay Community Energy's Brilliant 100 product and focusing on outreach via a new website. The Subcommittee suggested staff work on improvements to the City website's sustainability page, introduced the idea of creating a "Conscious Living" campaign, and discussed the community engagement process for development of the Climate Mitigation and Adaptation Plan.

6-4. Discussion of Committee Role in Clean & Active Transportation Initiatives

Griffing and Polevy provided an overview of the City's efforts to promote clean and active transportation, which include pedestrian and bicycle infrastructure improvements, public transit projects, zero emissions vehicle infrastructure, trip reduction services, and education and outreach initiatives.

The committee discussed possible future agenda items, including:
