SUMMARY

The City of Albany utilizes the services of the Sloan Sakai Yeung & Wong, LLP law firm for labor relations matters. The current contract with this law firm was entered into in 2018 for a one-year term. Staff proposes that the City amend the current contract to authorize additional expenditures and extend the term of the agreement one year.

STAFF RECOMMENDATION

That the Council adopt Resolution No. 2019-11, approving Amendment No. 1 to the agreement (C19-31) for specialized legal services in the area of labor relations.

BACKGROUND/DISCUSSION

The City has represented employee units which require State-mandated collective bargaining pursuant to the Meyers-Milias-Brown Act (MMBA) when terms of employment become negotiable through either meet and confer requirements or negotiation efforts. Depending upon the circumstances, staff utilizes the services of a professional labor law firm to provide bargaining and other labor relations services. The law firm of Sloan Sakai Yeung & Wong LLP ("Sloan Sakai") provides responsible services to public agencies concerning complex labor negotiations and collective bargaining issues.

The current agreement between the City and Sloan Sakai was entered into in 2018, with a one-year term and a not-to-exceed amount of \$25,000. The City has incurred approximately \$24,996.83, with pending matters which will result in additional expenses. Furthermore, the City is currently in negotiations with the Albany Fire Fighters' Association and expects to begin negotiations with the Albany Peace Officers' Association in late 2019. In order to provide additional authorization for current and future labor relations assistance, staff recommends that the City execute an amendment to the current agreement with Sloan Sakai. Staff recommends that the contract be amended to extend the agreement one year and authorize an additional \$50,000 with a total not-to-exceed amount

of \$75,000. This will provide flexibility for staff to respond quickly as the need for labor relations assistance arises from time to time.

FINANCIAL IMPACT

The proposed contract amendment authorizes an additional \$50,000 with a total not-to-exceed amount of \$75,000.

WHEREAS, the City has incurred approximately \$24,996.83, with pending and future matters which will result in additional expenses; and

WHEREAS, an amendment to the agreement with Sloan Sakai is required in order to provide additional authorization for pending and future labor relations assistance.

NOW, THEREFORE, BE IT RESOLVED, that the Albany City Council hereby approves the execution of Amendment No. 1 to the agreement with Sloan Sakai (Contract #C19-31) to extend the agreement one year and authorize an additional \$50,000 with a total not-to-exceed amount of \$75,000.
