Mayor Nason reported the appointment of members to the Charter Review Committee will occur after the Council meets in closed session to discuss the allegation that the City is in violation of the California Voting Rights Act.

Item 5-7: Capital Improvement Project Manager Robert Gonzales reported rehabilitation of Washington Avenue should occur in the late summer. Outreach to residents and businesses on

Solano Avenue and adjacent streets has begun. As the date for construction gets closer, outreach regarding the construction schedule will continue through letters, e-news, and the City website.

Public Works Director/City Engineer Mark Hurley reported staff chose to utilize a change order because the contractor is performing well and the contractor's bid is based on the prices charged a year ago. The bid falls at the lower end of the unit cost price. The City has to meet the Consent Decree agreement and the submitted US EPA recovery plan requirements.

Mayor Nason reported approximately 70 people attended the beach cleanup event.

Council Member Pilch reported he attended the Chamber Mixer with other Council Members. The next East Bay Community Energy (EBCE) meeting is scheduled for February 20.

Council Member Maass reported he attended a San Francisco Bay Area Planning and Urban Research Association (SPUR) presentation regarding development on Bay Area Rapid Transit (BART) parking lots.

Council Member Barnes reported he spoke to a meeting of the Haight neighborhood group regarding CASA.

Vice Mayor McQuaid reported she attended a juvenile justice forum with Chief Geissberger, the Chamber Mixer, the pancake breakfast, the Lunar New Year celebration, the UC Chancellor's Leadership Breakfast with Mayor Nason, the Mayor's Conference, Coffee with a Cop, and the YMCA Youth in Government VIP Day. The Albany High School girls' wrestling team won the North Coast Section Team Championship and the West Alameda County Conference League Championship. The boys' wrestling team won the Tri-County Athletic League Championship.

Assistant City Manager Isabelle Leduc recognized the Public Works Department for its work during the recent rain storms. Flooding was limited to known trouble spots, and no trees were lost. Landscape work at the Albany Loop art installation has begun and should be complete by the first week in March. The public comment period for the draft Solano Avenue Complete Streets Plan has opened, and the draft Plan is available on the City's website. Comments should be submitted by March 11. A shelter management class taught by the American Red Cross will be held on February 23. The City has hired four new employees, Nicholas Grech as Financial Analyst, Nancy March as Accounts Receivable Technician, Thomas Peters as Fire Inspector, and Andrea Gilmore as Program Leader III.

11-1. Study Session – Seismic Safety Soft-Story Retrofit Program

Staff recommendation: that the Council provide preliminary direction on the development of a soft-story seismic retrofit program

Community Development Director Jeff Bond presented the staff report. The Council Strategic Plan and the Local Hazard Mitigation Plan identify the need for a soft-story retrofit program. The building code applies to new construction only. State laws do not require retrofitting of existing structures. Many buildings in Albany do not meet modern seismic safety standards. The 1971 San Fernando Valley earthquake led to the adoption of the first meaningful seismic safety building code in California. Earthquakes since 1971 have contributed to the knowledge of seismic safety. New or retrofitted wood-frame single-family homes on level lots are considered the safest buildings for occupancy during an earthquake. In 1991, a retrofit program identified 41 buildings as needing seismic retrofitting, and 33 of the buildings underwent a permitting process. The first step in a soft-story retrofit program is to adopt a code standard. Next, the City would conduct a preliminary survey based on a visual inspection and set a threshold at which a property owner would be required to hire an engineer to perform a formal assessment. Based on the engineer's determination, the City could require a notice of potential hazard to be posted at the main entrance of the building and require retrofit within a specific timeframe. Property owners have due process appeal rights within a retrofit program. The Council could authorize staff to work with a property owner to find the safest feasible solution to improve the safety of the building. In a retrofit project, an engineer of record would design the project, and a consulting engineer would review it for compliance with codes. Potential policy issues include the cost of retrofit projects leading to increased rental rates; implementation of a retrofit project may result in loss of parking; during construction, tenants could be inconvenienced or temporarily displaced; and other hazards associated with a building can cause injury or make a building uninhabitable.

The following persons spoke: Preston Jordan, Keith Knudsen, Bob Outis. A summary of the comments is as follows: support for a retrofit program and utilizing different timelines for retrofit projects based on number of units or size of buildings; the need for a soft-story retrofit program; support for including commercial buildings in a retrofit program.

A summary of Council comments is as follows: support for developing a soft-story retrofit program, including commercial buildings, condominiums, and residential duplexes, and prioritizing buildings based on size and age; a suggestion to seek grant funding for a preliminary survey; amortizing the cost of a retrofit project over a period of time could benefit landlords and tenants; staff and consulting engineers should determine the appropriate retrofit standards; perhaps the program could include other hazards mentioned in the Hazard Mitigation Plan; perhaps the City can offer tax credits to landlords; parking, height, and setback requirements could be waived or reduced for retrofit projects; Oakland's ordinance may be a good model ordinance; tenants alone should not bear the cost of retrofit projects; a suggestion for the Council to consider partnering with another city to utilize economies of scale; the immediate goal of a program should be life safety; requiring the conversion from natural gas to all electric could reduce the fire risk for older buildings; data from a preliminary survey may assist the Council with establishing priorities.
