# 4-4. Update to Blue Curb Policy in Residential Areas

Staff is recommending an update to the blue curb policy in residential areas to clarify and streamline the process for applicants and align the policy with current practice.

**Recommendation:** That the Traffic and Safety Commission recommend that City Council adopt a resolution revising the blue curb policy in residential areas as proposed.

# 5-1. Proposed Curbside Management at Albany High School for Ocean View Elementary Student Relocation

Albany Unified School District will present proposed temporary changes to standard street parking areas and loading zones on the 1300 block of Portland Ave to accommodate elementary school pick-up and drop-off needs during the relocation of Ocean View Elementary students to the Albany High School campus.

**Recommendation:** Approve recommendation to staff to issue an encroachment permit to authorize curb markings.

# 5-2. Proposed School Loading Zone on East Side of Masonic South of Garfield

City staff is proposing a change in curbside designation for a three-minute school loading zone on the east side of Masonic Avenue between Garfield and Portland. The loading zone is intended as an alternative drop-off and pick-up location for Albany middle School.

**Recommendation:** Approve recommendation to staff to issue an encroachment permit to authorize curb markings.

# 5-3. Alameda County Transportation Commission San Pablo Avenue Corridor Study The San Pablo Avenue Corridor Project seeks to develop a long-term vision and near-term improvements for San Pablo Avenue to improve mobility, efficiency and safety for current and future users while supporting a strong local economy and communities. Staff will provide information presented by Alameda County Transportation Commission at a public workshop on April 4<sup>th</sup>.

**Recommendation:** For discussion only.

## 5-4. Update on Buchanan Marin Bikeway Phase IV

Phase IV of the Buchanan Marin Bikeway Project includes improvements to the San Pablo Avenue/Marin Avenue intersection and the Marin Avenue approaches

to the intersection. Staff will provide an update on the grant for this project, feedback from Phase III, and next steps.
