2 **A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE**  
3 **CITY MANAGER TO EXECUTE CONTRACT AMENDMENT #1**  
4 **TO CONTRACT #C18-61 FOR PROFESSIONALS SERVICES WITH**  
5 **NUTE ENGINEERING FOR SEWER REHABILITATION PRELIMINARY**  
6 **AND FINAL DESIGN SERVICES**

7 **WHEREAS**, the City of Albany owns and maintains approximately 35 miles of public  
8 sewer mains and approximately 14 miles of lower laterals; and  
9

10 **WHEREAS**, recent communication with the US Environmental Protection Agency  
11 (EPA) indicated that the City of Albany is out of compliance with its annual requirements for  
12 sanitary sewer main rehabilitation; and  
13

14 **WHEREAS**, staff presented a recovery plan to the EPA to meet compliance  
15 requirements by June 2020 that includes accelerated rehabilitation of 19,900 feet of sewer  
16 main by September 2020; and

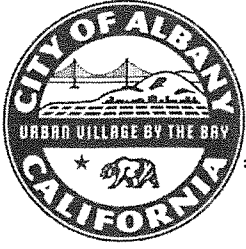
18 **WHEREAS**, Council has appropriated funds for sewer infrastructure improvement for  
19 FY2019/20 and FY2020/2021; and

21 **WHEREAS**, City has utilized Nute Engineers for engineering design services and is  
22 pleased with the quality of services and overall value of the work performed.

24 **NOW, THEREFORE, BE IT RESOLVED**, that the Albany City Council hereby  
25 authorizes the City Manager to execute Contract Amendment #1 to Contract #C18-61 with  
26 Nute Engineering in the not-to-exceed amount of \$200,000 to extend the contract one year  
27 for sewer rehabilitation preliminary and final design services from previously appropriated  
28 funds for the Annual Sewer Rehabilitation Project (CIP #32000) in FY19/20 and FY20/21.
