# 7. COUNCIL MEMBER REPORTS ON STATE/REGIONAL LOCAL MEETINGS ATTENDED AND ANNOUNCEMENT OF FUTURE MEETINGS/CITY MANAGER REPORT/COMMENTS

Mayor Nason reported she attended the Waste Management and Energy Council meeting, constituent meetings regarding conservation of historic resources and nonprofit musical education, the Albany Police Department dinner, a meeting regarding strategic planning, the East Bay Regional Park District Park Advisory Committee meeting, a census webinar, a briefing regarding the future of San Pablo Avenue, and the Alameda County Transportation Commission (ACTC) meeting. Vice Mayor McQuaid and Mayor Nason met with David Ackerly, Dean of the College of Natural Resources; assisted with a point-in-time count of the homeless population; and toured Codornices Creek with Berkeley Council Member Rashi Kesarwani. All Council Members attended a division meeting of the League of California Cities.

Council Member Maass reported he attended the League of California Cities' presentation regarding CASA. The San Francisco Bay Area Planning and Urban Research Association (SPUR) has scheduled a meeting regarding CASA on February 13.

Council Member Pilch reported he attended the California League of Cities meeting and the Police Department dinner.

Vice Mayor McQuaid reported she attended the Police Officer recognition dinner, the City staff recognition lunch, and a quarterly Community Emergency Response Team (CERT) training. In addition, she convened a discussion with business leaders and the Fire Department regarding disaster resiliency.

City Manager Almaguer reported the Planning & Zoning Commission and Traffic & Safety Commission will review a draft Solano Avenue Complete Streets Plan on February 13 and February 28 respectively. Ideally, the Council will review the draft plan in April. Lucas Aguila began working for the City as a Program Aide. Registration for the February 23 American Red Cross shelter management class is underway. Another sandbag filling assistance day is scheduled for February 19. Spaces are available for the spring CERT class.

#### 8. PRESENTATION

8-1. Annual Financial Statements and Annual Audit for FY 2016-17 and FY 2017-18

Staff recommendation: that the Council

- Receive presentation of the results from the City's independent auditor's examination of the City's financial reports for fiscal years ending June 30, 2017 and June 30, 2018; and
- 2. Accept and file the reports.

Finance Director Heather Rowden presented the staff report. The Summary of Net Position reflects a significant decrease in value of the City because it includes the City's pension liabilities, which will be paid over a number of years. The fund balance is approximately 40 percent of expenditures. Staff is drafting a fund balance policy to present to the Council for review. Audit findings relate to fiscal years 2016-17 and 2017-18 specifically, not to current City practices. Prior to issuance of the Auditor's report, steps have been taken to rectify issues addressed. For the current fiscal year, staff has completed bank reconciliations for the main account and retains documentation for journal entries. In addition, staff is reviewing transfers from the main account to ensure funds were allocated correctly. Finance Director Rowden regularly reviews the payroll master file. The office will soon be fully staffed, and a reorganization of the office has been implemented with procedures for each assignment to ensure employees are performing effectively and efficiently.

Ahmed Badawi, Badawi & Associates, reported on the City's basic financial statements, internal accounting controls, and compliance with generally accepted accounting principles. The auditors have determined that they are not in a position to provide an opinion regarding the City's financial statements for fiscal years 2016-17 and 2017-18 because accounts were not timely reconciled and the cash allocation to funds could not be verified due to issues with implementation of the new accounting system, lack of documentation and significant staff turnover. Certain deficiencies in internal controls were identified as material weakness in financial closing and reporting, cash and investments, capital assets, journal entries, and beginning balances. A significant deficiency was identified regarding the payroll master file. Ultimately, City management is responsible for financial statements; establishing and maintaining internal controls; making all financial records available to auditors; informing auditors of all known and suspected fraud; complying with laws and regulations; and taking corrective action on audit findings.

City Manager Nicole Almaguer advised that the City's Finance Department has the appropriate number of staff positions. The City has hired staff who are able to fulfill the responsibilities of their positions.

A summary of Council comments is as follows: concern about the effects of staff turnover when staff turnover is inevitable; the Council needs to be aware of the ramifications of the audit on funding opportunities.

8-2. Proposed Addition of Financial Management Goal to the City Council Strategic Plan

Mayor Nason recommendation: that the Council:

- Give direction to the City Manager regarding the City Council's objectives for financial management; specifically, that pending adoption of a full set of revisions to the City Council Strategic Plan, the Council add the following Objective and associated set of Strategies under Goal 5, which is "Facilitate Government Accountability:"
  - a. Objective: 5.1 Sound and Transparent Management of City Financial Resources (new objective);
  - b. Strategies: (1) accurate comprehensive annual financial reports will be audited and produced to the Council by December 31st of each year; (2) the City will have a format for the presentation of budgets and budget-to-actual reports that is transparent to the City Council and the public at large, and these documents are accurate and timely produced; (3) a smooth transition will be implemented pursuant to Measure N from the City Treasurer model to a staff-based system of revenue collection and financial management with citizen oversight by a Committee on Budget and Finance; (4) the City Manager will have the capacity to timely respond to reasonable requests for financial information from members of the City Council; (5) the City will adopt and maintain a long-term financial plan that takes into account foreseeable needs, including but not limited to retirement benefits and the maintenance and replacement of infrastructure and other assets, to facilitate planning, to be transparent with the public, and to reduce the risk of financial problems over time and across economic cycles;
- 2. Direct the City Manager to prepare "action items" to implement the strategies and present them to the Council at the first Council meeting in March.

Mayor Nason recommended the City Council add a Financial Management goal, objective, and strategies to the Strategic Plan when the Council next discusses the Strategic Plan.

Staff recommendation: that the Council introduce for first reading Ordinance No. 2019-02, updating the name of the Park and Recreation Commission to the Parks, Recreation and Open Space Commission and updating the charge of the Commission to include open space

City Manager Almaguer presented the staff report. On December 3, 2018, the Council directed staff to amend the name and charge of the Parks and Recreation Commission. At its January 10, 2019 meeting, the Parks and Recreation Commission supported the name Parks, Recreation, and Open Space Commission in place of Parks, Recreation, and Natural Areas Commission because the phrase open space aligns with planning documents and the general definition of open space areas. Open space areas within the City include creeks, Albany Waterfront, and Albany Hill.
