6-1. Review and Approve Summary of Comments on Solano Avenue Compete Streets Planning Process

The Committee discussed the comment summary and suggested minor edits:

- Support further study of back-in angle parking and engage seniors in the process
- Support further study of potential for one or two protected cycletracks for safety, and identification of potential impacts on parking
- Ensure cohesion with lower ("western") Solano Avenue, and focus on authentic branding of the district
- Only implement projects that can be maintained
- Increase public art like murals and interactive sculptures

- Encourage sidewalk dining
- Establish gathering and performance spaces and a place for a farmer's market
- Ensure delivery trucks can make turns and have loading zones
- Consider establishing rideshare pickup zones
- · Minimize loss of parking
- Research proposed center islands further to ensure they accommodate all users
- Minimize the effect of construction on businesses by earmarking funds for advertising that businesses are stull open and keep sidewalks open as much as possible during construction
- Balance maximizing parking availability and safety while supporting all modes of travel
- Focus on bike safety and bike and scooter parking
- Place trees strategically and favor species with tall canopies to minimize obstruction of business signage

Farmer's Market: Charles, Sala

Private lots present challenges, so they recommended closing off the northwest side of Key Route at Solano Avenue as a central location for a market. They surveyed other markets in the area and determined Wednesdays and Fridays are the best days. They recommended incorporating small scale entertainment and food trucks and emphasizing prepared food.

Marketing & Outreach: Montagh, Tiedemann

They recommend focusing on two separate outreach campaigns, one for business attraction and one for retention. They suggest focusing on customer attraction in the future.

Arts Committee Liaison: Andrea Goldman was appointed as the Arts Committee Liaison.
