## IN RECOGNITION OF ALBANY RECREATION & COMMUNITY SERVICES DIRECTOR CHELLE PUTZER'S SERVICE TO THE CITY OF ALBANY

WHEREAS, Michelle Putzer, a.k.a. Chelle Putzer, commenced service with the City of Albany as an Albany Recreation Supervisor on September 12, 2003; and

WHEREAS, Chelle Putzer was promoted to the position of Administrative Management Analyst on November 12, 2007; and

WHEREAS, Chelle Putzer was promoted to the position of Albany Community Services Manager on June 29, 2009; and

WHEREAS, Chelle Putzer was appointed to the position of Albany Recreation & Community Services Director on June 16, 2014; and

WHEREAS, Chelle Putzer, during the 16 years of service to the City of Albany, worked with staff in the Recreation & Community Services Department to facilitate many community engagement programs and events including: Dinner with Albany, Music in the Park, Civics Academy, Alberrito Streets, @the Center, Albany Local Week, Block Movie Nights, Songs on Solano, Noon Year's Eve, Commit to Serve Expo, Fireside Songs and S'mores, Bike About Town, A Very Albany 4<sup>th</sup> of July – Green, Red, White & Blue Celebration!, the various Swapping Events, and many other programs enjoyed by the community; and
