**A RESOLUTION OF THE ALBANY CITY COUNCIL APPROVING  
CONTRACT NO. C20-33 WITH BEST, BEST & KRIEGER, ATTORNEYS  
AT LAW FOR THE PROVISION OF CITY ATTORNEY SERVICES  
FOR THE CITY OF ALBANY**

**WHEREAS,** Craig Labadie was appointed by the City Council as the City of Albany City Attorney in 2012; and

**WHEREAS,** Craig Labadie will be retiring from the position of City Attorney for the City of Albany in December 2019; and

**WHEREAS,** on September 3, 2019 the City Council authorized issuance of a Request for Proposals for City Attorney Services; and

**WHEREAS,** a Request for Proposals for City Attorney Services was issued on September 5, 2019, and a total of ten proposals were received; and

**WHEREAS,** the City Council reviewed the proposals received and conducted interviews with a select group of firms on November 25, 2019, and ultimately selected Mala Subramanian of Best, Best & Krieger as the attorney with the knowledge and qualifications most well suited for the position of City of Albany City Attorney.

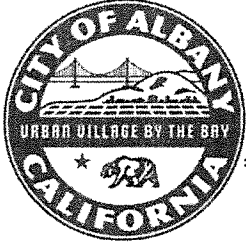
**NOW, THEREFORE, BE IT RESOLVED,** that the Albany City Council hereby approves Contract No. C20-33 with Best, Best & Krieger, Attorneys at Law for the provision of City Attorney Services for the City of Albany, with service to the City commencing January 1, 2020; and

**BE IT FURTHER RESOLVED,** that per the contract agreement, Malathy Subramanian shall be designated as City Attorney, and shall be primarily responsible for

1 the performance of all services under the Agreement, including the supervision of  
2 services performed by other members of Best, Best & Krieger, and no change in this  
3 assignment shall be made without the express approval of the City Council.
