

To Whom it May Concern:

I'm writing in support of converting the rarely used tennis courts at Ocean View to permanent pickleball courts in the near future.

I've been an avid pickleball player for just over two years now. Since that time, I've met more than 300+ people along with way on the courts. I can't tell you what a wonderful sport this has become in my life both physically as well as socially.

Don't get me wrong, I love all sports including tennis but what I've found is the few amount of tennis players who will occupy a court at any given time. Pickleball courts seem to be filled with waiting lists whenever I venture out to a court on a non-rainy day. The difference is a tennis game may take quite long with generally two players on the court. With pickleball, you will generally see four players on a court. Games typically take 12-15 minutes versus a much lengthier time for tennis as pickleball is faster paced.

Up to four pickleball courts can replace one tennis court thus it's possible to have 16 players on all courts versus two to four players on one tennis court, maximizing the use of recreational space.

The cities of Walnut Creek, Concord, Oakland, Berkeley, Vallejo and Benicia all have pickleball courts. There is a need to fill a void for the City of Albany to offer permanent courts for the residents of Albany.

Albany Park & Rec Commissioners,

I am writing in favor of converting the Ocean View tennis courts to permanent pickleball courts.

I know you have received many passionate appeals from both pickleball and tennis enthusiasts. Certainly both sides have merit and it is too bad that resources (land and financial) are limited. Deciding how to allocate resources, physical and financial, is a balancing act. Balance over time requires adjustment. When tennis courts were built pickleball did not exist. As the courts at Cedar Rose have shown, there are many more people using the one former tennis court than make use of the other two, newly resurfaced tennis courts. Shifting the balance at Ocean View does require eliminating two tennis courts but the benefits in terms of active use of facility seems clear to me for the following reasons:

- 1) OCEAN VIEW COURTS HAVE BEEN UNDERUTILIZED FOR YEARS. In her September 2019 report to the Commission, Chelle Putzer displayed a pie chart showing that 80% of the rental reservations for Ocean View tennis courts was for non-tennis events. As I said at the December meeting, I went around to Memorial, Ocean View and the new Cedar Rose pickleball courts in Berkeley a half dozen times this fall to see what was happening. Usually, there were one or two courts at Memorial in use by tennis players playing singles (one time all four courts were used for singles, so 8 players); usually all four pickleball courts were in use at Cedar Rose for doubles (16 players) with 2-10 people waiting); and no one was at Ocean View playing tennis except for one time when two people were playing tennis on one court.
- 2) CASUAL (i.e. UNRESERVED) USAGE OF THE TENNIS COURTS BY PICKLEBALL PLAYERS GREATLY EXCEEDS THAT OF TENNIS PLAYERS. Cathy Taruskin kept a log for six months of open play pickleball sessions at Ocean View on Wed. Fri. Sat. and Sun afternoons. (This was before the Cedar Rose courts opened). There were over 2,100 visits by pickleball players during that time. It's unfortunate that we do not have exact counts of casual tennis usage. However, due to the nature of tennis play (primarily singles who show up ad hoc) vs. pickleball play (where groups of 10-20 show up for pre-announced open play sessions), there is no evidence to suggest that tennis usage counts come anywhere near the counts we have tracked for pickleball.
- 3) TENNIS PLAYERS HAVE MULTIPLE QUALITY OPTIONS FOR OTHER PLACES TO PLAY NEARBY. There are abundant places to play tennis in Albany, Berkeley and El Cerrito including many with lights for playing at night and late afternoon in the winter. Our experience is that tennis players who find Memorial full tend to go to one of 18 tennis courts within 1.5mi (9 of them closer to Memorial than Ocean View). Since pickleball players were at Ocean View on four late afternoons a week, we would know if tennis players were showing

up to use the courts – they weren't.

- 4) MANY CITY RECREATION DEPARTMENTS ARE RECOGNIZING THE BENEFIT OF ADDING PICKLEBALL TO THEIR OFFERINGS. Pickleball did not exist when cities developed tennis courts as a regular resource in public parks. Now, all over the country, cities are either creating new pickleball courts if they can or converting tennis courts. It would be beneficial to all residents of the East Bay shoreline cities if the separate Park and Rec Departments cast a wider view as they decide what facilities to develop, maintain and change. There are already many single use tennis courts in Albany and adjacent cities. There is only one venue dedicated for pickleball (the 4 new courts at Cedar Rose in Berkeley). In terms of the number of people already playing pickleball and how that number is rapidly growing, this is a discrepancy that needs to be addressed.
- 5) THE PICKLEBALL POPULATION IS RAPIDLY GROWING. The email group that was started when the Cedar Rose courts opened in August has grown to 380, mainly because people who go by are curious to give it a try and want to keep coming back. It has been wonderful to see families playing together and children on their own coming to use the courts. This, in addition to single adults showing up to wait their turn to play into the rotation since, informally, players know they will find others to play with every morning 10-12 and after 3pm.
- 6) THE NUMBER OF PEOPLE REGULARLY SERVED BY 7-8 PICKLEBALL COURTS AT OCEAN VIEW WOULD EXCEED THE NUMBER OF TENNIS PLAYERS WHO USE OCEAN VIEW OCCASIONALLY. We do not relish the idea a taking away tennis courts from people who would use them. However, it's important to compare the numbers: 32 pickleball players could play simultaneously, and many of these people play 3-6 times PER WEEK. In contrast, a maximum of 8 tennis players could play simultaneously (and this scenario has never occurred in our regular observations of court usage over the years), and these players are more likely to use Ocean View on an irregular basis. Of the 26 tennis players who have taken the time to voice their opposition to the court conversion via emailed public comments (so far), only 3 claim to use the OV courts more than once a week. Some say they play at OV "regularly" or "often" but are not more sepeific, while the majority do not cite their own usage of theOV courts at all. Compare this to the scores of pickleball players who mentioned playing 3-10 times per week.
- 7) PICKLEBALL SERVES A GROWING SENIOR COMMUNITY THAT HAS LIMITED ATHLETIC OPTIONS. As a lot of the emails you received attest, pickleball has made "athletes" out of people who either never played sports or had given up due to age and/or injury. As important, it provides an opportunity for social engagement and fun for many people. It is not an exaggeration when you hear people say pickleball has greatly improved the quality of their lives. Increasing opportunities for people to socialize and play is an investment in public health.
- 8) PUBLIC SUPPORT FOR THIS PROPOSAL OUTWEIGHS OPPOSITION The number of public comments on this issue speaks volumes. Based on the PUBLISHED comments today, over 156 letters (86%) were in favor of the court conversion, versus 26 opposed. In December, some Commissioners expressed concern that the word had not reached all of the tennis players. We'd like to point out that a number of tennis players have told us they have not written simply because they don't object they see our request as a reasonable and fair means of sharing city resources.

9) PICKLEBALL PLAYERS ARE WILLING TO HELP FUND THIS INITIATIVE. The local pickleball community has already raised almost \$10,000 to help the City fund the conversion and improve lighting. This is a very strong indication of the number of people who support this proposal.

We feel that you are looking at three options:

- 1) DO NOTHING In view of the public support and interest in pickleball, we hope this option is off the table. Dual striping is increasingly unpopular solution among both pickleball players and tennis players. Each sport deserves its own facilities.
- 2) COMPROMISE: Convert one tennis court to four pickleball courts. While this may seem like a reasonable compromise, it has several drawbacks. A fence will be needed between the courts to contain errant balls, reducing the playable area and making it even less desirable to tennis players. Also, with a 1-tennis + 4-pickleball court layout, there is no place for pickleball players to wait in line for a court (other than on the tennis court). Finally, without 7-8 pickleball courts the opportunity to hold leagues and tournaments and generate reservation income for the City will not exist.
- 3) CONVERT BOTH TENNIS COURTS TO 8 PICKLEBALL COURTS. This is the long-term solution we seek, for the reasons I've outlined above.

Finally, a note on timing. At the last Commission meeting Harriet Patterson mentioned that the work to convert the tennis court at Cedar Rose seemed to take a considerable amount of time. Cathy Taruskin and I were directly involved in working with the City of Berkeley on this initiative, and can probably answer any questions you have about it. It should be noted that (1) those courts were in much worse shape than Ocean View, with many wide and buckled cracks to fix; (2) the contractor was resurfacing 3 courts not 2 and had other work he was doing for the City at the same time (work on the bike path and a nearby basketball court); and (3) the court conversion was actually completed several weeks before the opening because the City wanted to finish landscaping surrounding the courts.
