SUMMARY

The action before the City Council is to approve a professional services contract for on-call land surveying and civil engineering services with Oberkamper & Associates Civil Engineers.

STAFF RECOMMENDATION

That the Council adopt Resolution No. 2020-03 authorizing the City Manager to execute a professional services contract with Oberkamper & Associates Civil Engineers for on-call land surveying and civil engineering services for an amount up to \$100,000 through June 30, 2022.

BACKGROUND/DISCUSSION

Historically, the City has used consultants to provide consulting on technical engineering issues. In the past, the City has worked with on-call engineering consultants who complete technical reviews of land division applications including lot line adjustments, parcel maps, subdivision maps, and condominium maps.

Oberkamper & Associates is an engineering consulting firm based in Novato that provides a full range of civil engineering and land surveying services. The proposed contract would allow the City to work with Oberkapmer & Associates for consultation and review of land division applications pursuant to the California Subdivision Map Act. Application requests filed include lot line adjustments, parcel maps, subdivision maps, and condominium maps. These project requests are filed with the Community Development Department and require compliance review by a licensed engineer or land surveyor. The City does not have a dedicated staff person with land surveying expertise.

Consultant services are utilized on an as needed basis. Applicants filing applications pursuant to the California Subdivision Map Act pay an initial deposit and are charged for cost recovery of the time and services rendered by the consultant.
