

Hi Parks and Recreation Commission members,

I am writing to see if the City of Albany can look at using the Albany Soda Tax money to help fund new bike racks at the Albany Middle School Annex. Currently, there are not any public bike racks along Brighton or San Gabriel where the Middle school is located. There are some bike racks just inside the middle school gates but I was told by the Site Supervisor for the school that those are for employee use only. I bike my kids to the Middle school almost everyday. Bicycling is my family's main mode of transportation around town.

If we are encouraging our kids and being positive roll models for our kids to live a more environmentally friendly lifestyle, than bike racks are critical to supporting that effort. Attached are a couple pictures that I recently took of the new Annex. As you will see, people who bike there end up locking their bikes on stairway guardrails and making it unsafe for those using the stairway. To avoid this, adding some bike racks in front of the Annex main entry area would be desired. Additionally, adding some to the Middle school main entry would also be beneficial since there currently aren't any for public use.

Both the middle school and annex do have some 'private' bike racks on the school site for kids to park, however after a certain school hour, the campus is closed and locked and therefore for evening events and/or evening pick ups, the bike racks are not accessible for use. Worse, if a child locks the bike up in these 'private' areas in the morning for drop off and a parent picks them up at night during after school care, they are not able to get the child's bike out of these locked 'private' bike racks until the next day.

I hope you can understand my reason for wanting to see if the City can provide some public bike racks at the middle school and annex. I hope you take this into consideration and appreciate your help in supporting a carbon neutral Albany.
