## 4-2. Electrify Everything Workshop and Carbon-Free Albany Challenge

Bianca Hutner provided an update – The City will host an "Electrify Everything" workshop on January 26, 2020 at the Albany Community Center. The workshop will cover electrification opportunities for vehicles, space and water heating, and other home appliances. There will also be a presentation on the 2020 Carbon-Free Albany Challenge, and an opportunity for attendees to form teams with friends and neighbors for the challenge.

## 4-3. All-Electric Ordinance Update

Carrade provided an update - The City of Berkeley, which adopted a similar ordinance in July 2019, is being sued by the California Restaurant Association. The City of Albany will sit down with legal counsel in early 2020 to take a closer look at the ordinance and the lawsuit and discuss next steps.

## 4-4. Climate Action and Adaptation Plan Update

The Albany City Council unanimously approved the Climate Action and Adaptation Plan on December 2, 2019 with a few minor changes. The interim target was changed from 60% greenhouse gas reductions by 2035 to 70% reductions by 2035.
