**A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING
THE SUBMISSION OF FY2020-21 PARATRANSIT PROGRAM PLAN
APPLICATION TO THE ALAMEDA COUNTY TRANSPORTATION
COMMISSION AND AUTHORIZING THE CITY MANAGER TO ENTER
INTO AN AGREEMENT WITH THE ALAMEDA COUNTY
TRANSPORTATION COMMISSION FOR THE PROPOSED USE OF FY
2020-21 MEASURE B & BB FUNDS IN THE AMOUNT OF \$69,129.82**

WHEREAS, in November 2000 the voters of Alameda County approved the half-cent transportation sales tax through the passage of Measure B, re-approving the tax measure originally passed in 1986; and

WHEREAS, in November 2014, voters approved Measure BB which renews the half-cent transportation sales tax approved in 2000 and increases the tax by another half-cent; and

WHEREAS, the Alameda County Transportation Commission has the responsibility for administering funds collected from the Measures; and

WHEREAS, the Alameda County Transportation Commission has projected for Fiscal Year 2020-21 that the City of Albany will receive \$69,129.82 for Paratransit services; and

WHEREAS, the City of Albany Paratransit Programs will provide subsidies on Taxi and Transportation Network Companies rides, group trips to go shopping and recreational day trips.

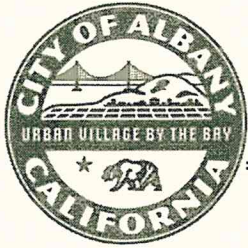
