7	WHEREAS, current Municipal Code provisions related to the Traffic and Safety
8	Commission were adopted in 1958; and
9 10	WHEREAS, the City Council in its periodic strategic planning and work plan review
11	processes requested modernization of the Commission's Municipal Code provisions; and
12	WHEREAS, changing the Commission name to the "Transportation Commission,"
13	better reflects the scope of Commission activities and is similar to the name used by other
14	municipalities.
15	NOW, THEREFORE, THE ALBANY CITY COUNCIL ORDAINS AS

18	SECTION 1: CHAPTER 2 OF THE ALBANY MUNICIPAL CODE, SECTION
19	2-20 TITLED "TRAFFIC AND SAFETY COMMISSION" IS HEREBY DELETED IN
20	ITS ENTIRETY:

22	2-20 TRAFFIC AND SAFETY COMMISSION.
23	2-20.1 Created; Composition.
24	-
25	There shall be and hereby is created a Traffic and Safety Commission within the City.
26	There shall be five (5) voting members of the Commission, with each member of the City
27	Council having the power to appoint one (1) voting member to the Commission. (Ord. #60-010,
28	§1; Ord. #71-024, §1; 1958 Code §20.9-1)

2	2-20.2 Ex-Officio Members.

4 5	Ex-officio members of the Traffic and Safety Commission shall be the Chief of Police,
6	the Fire Chief and the City Engineer. (Ord. #60-010, §2; 1958 Code §20.9-2)
7	the Pire Chief and the City Engineer. (Ord. #60-610, §2, 1756 Code §20.7-2)

9	2-20.3 Rules of Conduct and Procedure.

11	Rules of conduct and procedure for the Traffic and Safety Commission may be prepared
12	by the Commission and shall become effective upon approval by the Council of the City. (Ord.
13	#60-010, §3; 1958 Code §20.9-3)

15	SECTION 2: CHAPTER 2 OF THE ALBANY MUNICIPAL CODE, SECTION 2-20
16	TITLED "TRANSPORTATION COMMISSION" IS HEREBY ADDED AS FOLLOWS:

18	2-20 TRANSPORTATION COMMISSION
19	2-20.1 Purpose.
20	2-20.1 Turpose.
21	A Transportation Commission is hereby established to advise the City Council on transportation
22	policy and project planning and design on City-owned right-of-way. The Transportation
23	Commission will take into consideration mobility, safety, sustainability, accessibility, and equity
24	when making decisions or recommendations.
25	
26	2-20.2 Duties and Responsibilities.
27	The Transportation Commission shall have the following duties:
28	

- a. Serve as the advisory body to the City Council on matters related to transportation planning and policy, including: transportation elements of the General Plan; transportation improvement projects in the Capital Improvement Program; public transit service in the City; planning and design of bicycle, pedestrian, and motor vehicular facilities; and streetscape improvements on City owned right-of-way;
- b. Serve as a decision-making body on transportation-related matters as may be requested by the City Council or required by the Municipal Code;
- c. <u>Provide transportation-related policy and project support to other City</u> committees and commissions;
- d. Serve as the City of Albany Active Transportation Advisory Committee (Bicycle and Pedestrian Advisory Committee), composed of both bicyclists and pedestrians who live or work in the City pursuant to Metropolitan Transportation Commission Resolution 4108 and City Council Resolution No. 2015-18, as may be amended from time to time; and
- e. <u>Perform such other duties as may be requested by the City Council or identified in the Municipal Code.</u>
- f. Consider accessibility and equity in making all decisions.

2-20.3 Commission Structure.

- a. The Commission shall consist of five members with each member of the City Council having the power to appoint one member to the Commission;
- b. <u>The Commission shall have a Chairperson and a Vice-Chairperson who shall</u> be members of the Commission;

3	c. The Chairman and Vice-Chairman shall rotate per the Advisory Body rules
4	and procedures; and

6	d. The City Manager shall designate a staff liaison to the Commission.
7	
8	2-20.4 Meetings, Generally.
9 10	
11	a. Regular Meetings. The City Council shall establish by resolution the schedule
12	for regular public meetings of the Transportation Commission. A meeting may be
13	canceled or rescheduled for lack of quorum or other reasonable cause.
14	-
	b. Meeting procedures. The Transportation Commission shall follow the
15	provisions of State Law, the City Charter, the Municipal Code or other such laws,
16	regulations, or City policies or procedures that govern the conduct of public meetings and
17	advisory bodies.
18	-
19	c. Quorum. Three (3) voting members shall constitute a quorum.
20	
21	d. <u>Public Notice</u> . The Transportation Commission shall establish by resolution
22	procedures for public notice of agenda items.
23	
24	SECTION 3: PUBLICATION AND EFFECTIVE DATE.
	This ordinance shall be posted at three public places within the City of Albany and shall
25	become effective thirty days after the date of its posting.
