Re: Waiver of Penalties, Interest and Fees for Late Property Tax Payments

Mr. Levy,

The undersigned Mayors of Alameda County are concerned for the financial hardships that many of our residents and businesses face during these unprecedented times, while also balancing our ability to financially sustain essential services to the community during this pandemic, including public safety, health and human services, and the maintenance of critical infrastructure.

The COVID-19 pandemic and the Governor's historic stay-at-home Executive Order, prudent as it is, affects every resident and business financially. Many work hours are being reduced, families are forced to take time off from work to care for home-bound school age children or sick loved ones, and some are being laid off. Many are concerned about how they will pay the rent or mortgage, utilities, insurance, or property taxes, let alone food for their families. We applaud the Governor's work in urging banks to defer principal repayment and his most recent action on March 27th imposing eviction protections for tenants who are unable to pay the rent due to loss of income as a result of the outbreak.

April 10 is the deadline to pay property taxes in California. We, too, understand the hardships our households are experiencing and would support countywide action to waive late fees on property tax payment for 60 days for residents undergoing a demonstrated and verifiable economic hardship. We believe that you can exercise your authority pursuant to Revenue and Taxation Code Sections 2619 and 4985.2 to waive interest or penalties that would otherwise be imposed or collected with respect to a delinquent second installment of property taxes levied for the 2019-2020 fiscal year on residential real property.

We trust that the proper parameters can be developed to demonstrate economic hardship and is fair and equitable for those in need. These revenue sources are not only relied upon by cities and counties, but also special districts, public agencies and school districts to meet basic payroll, purchase supplies and meet ongoing debt obligations. This cashflow is more critical now, than ever before. For these reasons, our recommendation has been developed with these parameters in mind.
