## **RESOLUTION NO. 2020-33**

A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE CITY MANAGER TO EXECUTE A MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF ALBANY AND AC TRANSIT FOR THE ADMINISTRATION AND CONSTRUCTION REIMBURSEMENT OF A NEW BUS STOP/PARKLET PROJECT AT 1116 SOLANO AVENUE

**WHEREAS,** AC Transit filed an encroachment permit application with the City of Albany on January 11, 2018; and

WHEREAS, the City Council held a public hearing and considered all public comments received, presentation by City staff, the staff report, and all other pertinent documents regarding the proposed request and adopted Resolution No. 2018-45 on April 16, 2018 directing staff to issue the encroachment permit for AC Transit; and

WHEREAS, Andrew Cohen on behalf of Mr. Dewie's Cashew Creamery filed an encroachment permit application on July 20, 2018 for a bus stop/parklet at 1116 Solano Avenue; and


WHEREAS, the City Council held a public hearing and considered all public comments received, presentation by City staff, the staff report, and all other pertinent documents regarding the proposed request and adopted Resolution No. 2018-135 on November 19, 2018 approving the bus stop/parklet at 1116 Solano Avenue; and

WHEREAS, AC Transit authorized \$70,000 for the construction of the bus stop/parklet and requested that the City of Albany enter into a Memorandum of Understanding for construction reimbursement to the Project Sponsor – Mr. Dewie's Cashew Creamery.
