3 **THE SUBMISSION OF A FY 2019-20 COMMUNITY DEVELOPMENT**
4 **BLOCK GRANT PROJECT APPLICATION TO ALAMEDA COUNTY**
5 **AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN**
6 **AMENDMENT TO AN AGREEMENT WITH ALAMEDA COUNTY FOR**
7 **FY 2019-20 COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS**
8 **FOR ADDITIONAL COVID-19 FUNDS IN THE AMOUNT OF \$25,000**

9 **WHEREAS**, on July 1, 2019, the City Council authorized staff to execute
10 Alameda County Agreement No. 18920 (COA tracking No. C20-4) between the City of
11 Albany and Alameda County for the proposed use of FY 2019-20 Community
12 Development Block Grant (CDBG) funds projected in the amount of \$588,741; and

14 **WHEREAS**, additional funds for CDBG-eligible projects have recently been
15 made available from the CDBG Urban County COVID-19 funds; and

16
17 **WHEREAS**, the requirement that across the Urban County cities collectively, no
18 more than 15% of CDBG funds can be applied toward services has been waived for
19 COVID-19 funds; and

21 **WHEREAS**, the City's Homeless Outreach and Engagement program has been
22 expanded in response to COVID-10; and

23
24 **WHEREAS**, Albany's COVID-19 CDBG allocation in the amount of \$25,000
25 will be assigned to the Homeless Outreach and Engagement Program; and

27 **NOW, THEREFORE, BE IT RESOLVED**, the Albany City Council authorizes
28 the submission of FY 2019-20 Community Development Block Grant (CDBG) project
29 applications to Alameda County and authorizes the City Manager to enter into
