7 The City Council (the “Council”) of the City of Albany (the “City”) does resolve as follows:

8 **WHEREAS**, the Council previously completed its proceedings in accordance with
9 and pursuant to the Landscaping and Lighting Act of 1972, Part 2, Division 15 of the
10 California Streets and Highways Code (commencing with Section 22500) (the “Act”) to
11 establish the City’s Landscaping and Lighting Assessment District No. 1988-1 (the
12 “Assessment District”); and

14 **WHEREAS**, the City has retained NBS for the purpose of assisting with the annual
15 levy of the Assessment District, and the preparation and filing of an Annual Report; and

17 **WHEREAS**, the City has, by previous resolution, declared its intention to hold a
18 Public Hearing concerning the levy and collection of assessments within the Assessment
19 District; and

21 **WHEREAS**, a Public Hearing has been held and concluded and notice thereof was
22 duly given in accordance with Section 22626 of the Act; and

24 **WHEREAS**, at the time and place specified in the Resolution of Intention the City
25 conducted such hearing and considered all objections to the assessment.

- 4 **1. Confirmation of Assessment and Diagram:** The Council hereby confirms the
5 assessment and the diagram as is described in full detail in the Annual Report on file
6 with the Clerk.

- 8 **2. Levy of Assessment:** Pursuant to Section 22631 of the Act, the adoption of this
9 resolution shall constitute the levy of an assessment for the fiscal year commencing
10 July 1, 2020 and ending June 30, 2021.

- 14 **3. Ordering of the Levy:** The Council hereby orders NBS to prepare and submit the
15 levy of assessments to Alameda County for placement on the Fiscal Year 2020/21
16 secured property tax roll.
