WHEREAS, the California Department of Housing and Community Development ("Department") has issued a Notice of Funding Availability ("NOFA") dated April 30, 2020, under the Transit-Oriented Development ("TOD") Housing Program; and

WHEREAS, the City of Albany ("City") wishes to apply for and receive an allocation of funds through the TOD Program for the SAHA Albany Family Housing Project; and

WHEREAS, the City of Albany is an Eligible Applicant under the TOD Program and wishes to apply for a TOD Program Grant in an amount not to exceed \$5 million ("TOD Grant") to develop infrastructure in support of affordable housing ("TOD Project") under the above described NOFA.
