
1	ORDINANCE NO. 2020-08
2	AN ORDINANCE OF THE CITY OF ALBANY REPEALING SECTION 4-4 ("TELEPHONE, GAS AND ELECTRICITY USERS TAX") OF CHAPTER IV ("FINANCE") OF THE CITY OF ALBANY MUNICIPAL CODE

6	WHEREAS, Albany Municipal Code, Section 4-4 ("Telephone, Gas and
7	Electricity Users Tax") of Chapter IV ("Finance") was originally adopted in 1958; and
8	
9	WHEREAS, Ordinance No. 2010-03, codified as Albany Municipal Code,
10	Section 4-11, Utility User's Tax, was approved as Measure O at the election of November
11	2, 2010. Section 4-11, is known as the "Electric, Gas, and Communication Users' Tax
12	Law" of the City of Albany; and

14	WHEREAS, Section 4-11 established a modern Utility User's Tax ordinance that
15	was intended to replace Section 4-4, but Section 4-4 was inadvertently not repealed when
16	Section 4-11 was adopted in 2010; and
17 18	WHEREAS, the City Council desires to repeal Section 4-4 to eliminate possible
19	confusion as to the applicable Utility User's Tax ordinance in effect within the City of
20	Albany.
21	NOW THEREFORE, THE ALBANY CITY COUNCIL DOES ORDAIN AS
22	NOW THEREFORE, THE ALBANT CITT COUNCIL DOES ORDAIN AS
23	FOLLOWS:
24	SECTION 1: SECTION 4-4 REPEALED. Section 4-4 (entitled "Telephone,
25	Gas and Electricity Users Tax") of the Albany Municipal Code, including subsections 4-
26	4.1 to 4-4.17, is hereby repealed and reserved.

SECTION 2: PUBLICATION AND EFFECTIVE DATE. This Ordinance shall be posted at three public places within the City of Albany and shall become effective thirty days after the date of its posting.
