3                   **A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE CITY**  
4   **MANAGER TO EXECUTE CONTRACT NO. C21-07**  
5                   **FOR PROFESSIONAL SERVICES WITH NUTE ENGINEERING FOR**  
6                   **PRELIMINARY AND FINAL SEWER REHABILITATION DESIGN SERVICES**

8                   **WHEREAS,** the City of Albany owns and maintains approximately 35 miles of public sewer  
9 mains and approximately 14 miles of lower laterals; and

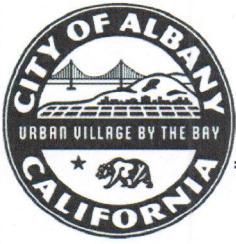
11                   **WHEREAS,** the City of Albany is signatory to a Consent Decree Agreement with the  
12 USEPA and the State Water Resources Control Board with annual requirements for sanitary sewer  
13 main rehabilitation; and  
14

15                   **WHEREAS,** City has utilized Nute Engineering for engineering design services and is  
16 pleased with the quality of services and overall value of the work performed, including work on  
17 the 2018 and 2020 Annual Sewer Rehabilitation Projects, during which Staff was able to accelerate  
18 sewer rehabilitation into compliance with the USEPA Consent Decree; and

20                   **WHEREAS,** Nute Engineering has provided a proposal for engineering design services for  
21 the 2021 and 2022 Annual Sewer Rehabilitation Projects, which Staff has deemed to be  
22 competitive with other firms offering this service.

24                   **NOW, THEREFORE, BE IT RESOLVED,** that the Albany City Council hereby  
25 authorizes the City Manager to execute Contract No. C21-07 with Nute Engineering in the not-to-  
26 exceed amount of \$288,500 for a two year contract for preliminary and final sewer rehabilitation  
27 design services, using previously appropriated funds for the Annual Sewer Rehabilitation Program  
28 (CIP No. 32000).
