A summary of Council comments is as follows: requiring the property owner to remove the wall seems pointless; the retaining wall is built in the original location and does not encroach onto the sidewalk.



Vice Mayor McQuaid reported she attended the League of California Cities annual conference, the Housing Authority of Alameda County meeting, the Alameda County Mosquito Abatement District meeting; the 2x2x2 meeting; the business workshop hosted by the Community Development Department; a ribbon-cutting event at Gnome, a United Against Hate meeting, a

meeting regarding nuclear power, and a conference call among staff, Mayor Pilch, and the City of Berkeley regarding mental health services.

Mayor Pilch reported he attended the Mayors' Conference, which will recommend the Association of Bay Area Governments (ABAG) utilize a Regional Housing Needs Assessment (RHNA) methodology proposed by the Tri-Valley Mayors. In addition, he participated in a conference call with other Mayors to discuss working with Alameda County regarding homelessness and allocating funding from Measure W, if it is approved. Mayor Pilch also participated in Alameda County's COVID conference call and attended the East Bay Innovation Awards. He announced his appointment to the Alameda County Transportation Commission's (ACTC) Bicycle and Pedestrian Advisory Committee.

A summary of public comments is as follows: hopes that the City of Albany can be included in the ILWU Local 75 recommendations.

8. CITY MANAGER REPORT

City Manager Nicole Almaguer reported the Fire Department patrols Albany Hill every day and twice on red flag days and has installed a fire hydrant near the park in preparation for wildfire season. Starting in November, staff will attend work sessions regarding equity and inclusion. A newsletter has been mailed to the community regarding resources, programs, projects and advisory body recruitments. More than 200 people submitted their ballots during the Early Voting Drop Stop event. The next event is scheduled for October 27 and 28, 2020, 10:00 a.m. to 4:00 p.m., at the Albany YMCA. The Registrar of Voters Office picks up ballots daily from the drop box at City Hall. Voters can track their ballot at acvote.org/go. Unfortunately, the Police Department will not distribute glow sticks to trick-or-treaters this year, but the public is invited to submit photos of their Halloween events. Albany Local Week is this week, and information as well as the score card can be found on the City's website. Recreation staff continue to deliver meals, groceries, and essential items and to take seniors on shopping trips. The 2020 sanitary sewer rehabilitation project is substantially complete. Phase 3 of the sidewalk program is progressing and should be complete in early November. In December, the Transportation Commission will review a plan for Phase 4 of the sidewalk program. Sewer cleaning and inspection work has begun at several locations and should be complete by mid-November. The Lower Solano ADA curb ramp project has been scheduled for construction in January.

9. PRESENTATION

9-1. Introduction of Kurt Wiest, new Executive Director of the Alameda County Housing Authority

Director Kurt Wiest was not present at the meeting to be re-introduced after the technical issue at the last meeting.

9-2. Quarterly Financial Update

Staff recommendation: that the Council receive a presentation on the quarterly financial update

Finance Director Heather Rowden presented the staff report. The estimated surplus for FY 2020 is higher than anticipated because the City received funds under the Coronavirus Aid, Relief and Economic Security (CARES) Act. Annual payments for general liability and workers' compensation insurance and the unfunded California Public Employees' Retirement System (PERS) liability cause the expenses to exceed budgeted amounts. Revenues are down compared to the first quarter of FY 2020. An additional \$500,000 will be paid toward the City's unfunded actuarial liability. The cost of general liability insurance is increasing. Overtime for the Fire Department has increased, but most of it will be reimbursed.

A summary of public comments is as follows: BART should pay taxes to the City.


12-1. Parks, Recreation & Open Space Commission Recommendation to Convert Ocean View Park Tennis Courts to Pickleball Courts

Parks, Recreation & Open Space Commission Recommendation: that the Council direct staff to conduct research needed to inform the Parks, Recreation & Open Space Commission's recommendation for specific pickleball facilities including the conversion of one tennis court at Ocean View Park to four permanent pickleball courts, retain one of the tennis courts, and allocate staff resources to support the Commission and community to decide the details of that configuration including possible enhancements to the tennis courts and lighting

Staff recommendation: that the Council:

- 1. Provide direction to staff regarding the Parks, Recreation & Open Space Commission recommendation for pickleball facilities at Ocean View Park; and
- 2. Consider including the evaluation of pickleball facilities as part of the update to the Parks, Recreation & Open Space Master Plan process to begin in the spring of 2021

Assistant City Manager/Recreation & Community Services Director Isabelle Leduc presented the staff report. The Parks, Recreation & Open Space Commission (Commission) has been exploring community interest in pickleball, receiving presentations from staff and pickleball players and comments from tennis players, learning about the game, and identifying potential modifications to infrastructure to accommodate pickleball courts at Ocean View Park. In February 2020, the Commission's pickleball subcommittee proposed that the Commission recommend the City Council convert one or both tennis courts at Ocean View Park to permanent pickleball courts with



the specific number of courts and layout to be determined through a research and design process that includes public input and outreach.

Prior to the pandemic, pickleball was offered at Ocean View Park on Tuesday afternoons and at Albany High School gym on Sundays. Pickleball may be played on tennis courts but requires different striping, which has been added to the tennis courts. In addition, pickleball courts have been striped at the ends of the tennis courts. Temporary nets must be installed on the courts for pickleball play. Through the master plan update process, pickleball facilities can be evaluated in the context of overall park usage; public comment can be received, and funding priorities can be identified.

Parks, Recreation & Open Space Commissioner Tod Abbott reported that the Commission's subcommittee met with staff and representatives of the pickleball community to learn about the game. The subcommittee found the issues to be more complicated than anticipated. Staff research is needed to provide the Council with a feasible recommendation.

A summary of public comments is as follows: support for pickleball courts; a proposal for four pickleball courts on one tennis court; support for implementing the proposal for four pickleball courts; a tennis court within biking distance is usually open for play at any time.

A summary of Council comments is as follows: interest in temporarily converting one tennis court into four pickleball courts and implementing a reservation system to gather data about demand and use of courts; the lines for four pickleball courts on one tennis court will be confusing for players; data about pickleball and tennis is needed; pickleball players may be willing to play with the existing condition of the tennis courts; the master plan update should explore permanent pickleball facilities and spaces outside parks; the tape used to line the courts will become a hazard; concern about expending funds for temporary measures when the master plan process will begin soon.


The Council directed staff to maintain the current arrangement for temporary pickleball courts and to include the evaluation of permanent pickleball courts in the process to update the master plan.
