**A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING
THE CITY MANAGER TO EXECUTE CONTRACT NO. C21-10 FOR
PROFESSIONAL SERVICES WITH CSG CONSULTANTS FOR PAVEMENT
AND CURB REHABILITATION DESIGN SERVICES**

WHEREAS, the City of Albany owns and maintains approximately 29 centerline miles of streets and roadways and approximately 60 miles of sidewalks; and

WHEREAS, on March 18, 2018, the City Council adopted Resolution No. 2018-36 adopting the FY17/18 – FY21/22 Capital Improvement Project budget including funding for the Annual Street Rehabilitation Program; and

WHEREAS, on August 7, 2020 staff invited qualified consulting firms to submit a proposal for preparation of preliminary and final design drawings, specifications, and engineer’s estimate of cost for approximately 21,400 feet of street rehabilitation; and

WHEREAS, on September 11, 2020, the City received seven proposal for engineering services; and

WHEREAS, City found that CSG’s Proposal for design services satisfies all the qualification requirements of the Request for Proposals, presented a clear understanding of the scope of work and that the Proposal’s cost estimate represents a good value for the city.

NOW, THEREFORE, BE IT RESOLVED, that the Albany City Council hereby authorizes the City Manager to execute Contract No. C21-10 with CSG Consultants in the not-to-exceed amount of \$498,850 for a two-year contract for pavement and curb rehabilitation

1 design services, using previously appropriated funds for the Annual Street Rehabilitation
2 Program (CIP No. 21000).

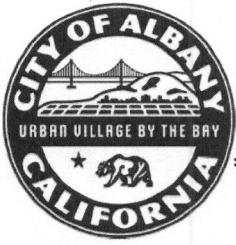
