Carrade provided an update - East Bay Community Energy (EBCE) invites community members to submit their Earth Day-inspired artwork design(s) for buttons and/or a poster. The selected buttons and posters will be available for distribution at EBCE's Earth Day events in April 2020. Artwork submissions are due no later than March 1, 2020. There will be a \$500 prize for chosen artwork.

4-5. Natural Gas Ban Update

Carrade provided an update – Staff is waiting to pursue a natural gas ban while the City Attorney researches lawsuits against similar bans filed in multiple jurisdictions. Staff will

continue to monitor the situation and provide updates as they become available. In the meantime, staff is working on other strategies aimed at reducing emissions in the building sector, which may include adopting stricter CALGreen building measures.

4-6. 2020 Tree Planting

Carrade provided an update – On February 18, the Albany City Council authorized a contract to Commercial Tree Care Company to plant 106 new street trees at 90 locations throughout the City.

6-1. Discussion on Motorized Garden Equipment –

Claire Griffing provided an update to the Committee, including analysis of neighboring jurisdictions' policies related to motorized equipment. The Committee agreed by consensus to recommend against a ban on leaf blowers and suggested that staff instead conduct outreach to property owners and landscapers regarding concerns with motorized equipment use and suggesting alternatives.

6-2. Green Building Update -

Carrade provided an update on CALGreen analysis. The Committee discussed pursuing a piecemeal approach to adopting Tier 1 measures for both energy and non-energy measures. The Building Electrification/UUT subcommittee plans to further analyze the approach at their next convening, and report back to the Committee during the next Climate Action Committee meeting.

6-3. Subcommittee Reports

Staff Recommendation: Receive updates from subcommittees.

Urban Forestry: The Urban Forestry subcommittee provided an update on funding sources identified for tree planting and support.
