Berkeley Food and Housing Project Narrative Report to City Council July 2019 – Sept 2019

Activities To-Date

The Albany Homeless Outreach and Engagement Program continued providing navigation and housing aftercare assistance to clients this quarter. The BFHP full time Albany Housing Navigator (HN) continues to work with Albany's two housed clients from our previous fiscal year. These clients are still involved in aftercare interventions in order to remain stably housed. Those individuals continue to require weekly staff check-in's to ensure continued stability, on-time rent payment, roommate civility and productive daily living.

One of the individuals is currently suffering from cancer. This person is in need of intense case management. We are attempting to connect this person with immigration solutions so that we are able to obtain the documents needed to house him in permanent supportive housing (PSH). Case management contacts have increased with this particular person, due to health issues.

Outreach interventions for unsheltered individuals in Albany are ongoing. The Albany housing navigator is building relationships within the Albany community. There are weekly visits to the local library, community center, Cares Program, and Shower program. The HN is consistently offering housing services, shelter, brochures, and information about PSH wait-list openings. The HN was able to make seven new unduplicated client contacts this quarter and perform initial enrollments with three.

The Albany HN has received several referrals through the Cares program, one of which has been housed through the Albany rapid rehousing (RRH) program.

Contact has continued with the Albany Neighborhood Service Manager as well as representatives of the Albany Police Department who requested outreach efforts to engage with approximately seven unsheltered individuals throughout the City of Albany. Once they were engaged in outreach, the Albany HN offered information about the City of Albany Homeless Outreach and Engagement Program, service referrals and other resources. We remain engaged with three of the seven referrals.

Successes in Quarter One

Albany Hope staff was able to maintain housing for four households at risk of losing their units, through the use of Homeless prevention funding. One of these was fleeing domestic violence. Services provided included 43 client contacts, and 29 life skill interventions, such as defining consistent and clear boundaries within the community, stating goals, managing income, and reinforcing client resilience for seven residents residing in Albany.

The Albany HN housed a family of three, with a newborn, in permanent supportive housing; a family of five with a disabled child in Rapid Re-housing, and a senior citizen in Senior housing that is based upon the income. The Albany HN was further able to creatively support the relocation of a person suffering domestic abuse utilizing the Alameda County Immediate Impact Grant funding.

Challenges in Quarter One

Lack of affordable housing in the current market remains an issue. BFHP has a relationship with one owner that has worked with our agency for many years. The trust that we have built benefits the Albany program. We have recently received an introduction to a new local owner. This person is willing to work with BFHP because of a positive reference. We will continue to search for property owners, and low-income housing units to support Albany clients.
