Activities To-Date

The Albany Homeless Outreach and Engagement Program provided navigation and housing aftercare assistance to clients this quarter. BFHP provides full time Albany Housing Navigator (HN) services and continues to work with Albany's two housed clients from our previous fiscal year. These clients are involved in aftercare interventions in order to remain stably housed. With the support of the HNs, both clients have applied for several long-term subsidized housing options for seniors and low-income households. The clients continue to receive weekly staff check-in's to ensure continued stability, on-time rent payment, roommate civility and productive daily living.

One of the individuals is currently suffering from cancer. As stated in our 2019-2020 Quarter 1 narrative, the HNs supported the client in accessing immigration documentation services. The client has since accessed these services and was provided an estimated waiting time for his citizenship application to be approved. HNs are supporting the client in determining his eligibility for financial benefits while his citizenship application is pending. We have updated the client's county housing assessment to convey his continuous health issues and need for immediate, long-term subsidized housing.

The HNs engaged in weekly outreach at the Albany library, community center, CARES program, and shower program. Additionally, outreach efforts are made to other areas of the city, such as Solano Ave and the Ohlone Greenway. The HNs have also responded to immediate outreach requests from the City of Albany, at times coordinating with the Albany Police Department to provide safe and effective outreach to individuals with high needs. We have engaged with sixteen new unduplicated clients this quarter while continuing to provide follow-up support for all previous clients enrolled into RRH or Albany outreach.

Follow-up support for previous enrolled clients has included transportation to medical appointments, referrals for mental health services, assistance at the Oakland social service office, and the provision of basic needs items, such as food and free mobile phones. All clients, both in RRH and unhoused, have been offered assistance with completing subsidized housing applications for various housing sites throughout the Bay Area. In the second quarter, the HNs supported clients in completing and submitting 21 subsidized housing applications.

Successes in Quarter 2

Four Albany Hope clients received Permanent Supportive Housing matches this quarter, with one officially receiving a COACH voucher. The remaining three clients who have not received a unit yet are now document ready.

Albany Project HOPE has established a master lease for a four bedroom house in Richmond, CA. HNs successfully supported three individuals with move-in at the home. We worked on setting-up

the house implementing a master lease plan and contract goal. Our BFHP Facilities Manager negotiated lease terms with the owner, as well the inspection, and securing the house. Once the leasing process was complete the HN then began to furnish the new master lease project with all household items, such as furnishings, bedding, kitchen and bath necessities. Once all items were purchased and delivered, the home set up began. Each bedroom has a twin bed, dresser, and desk. Bathrooms are fully stocked with household needs. The living room has a couch and inviting seating area for client congregation. The kitchen is set up for full use. The back yard has an outside seating area, and lovely vegetable garden for client reflection. This project took approximately 40 days total. Client move in was within 23 days from the lease start date of 12/1/2019. Clients were then placed in nearby motel for bedbug protocol and moved into the home 12/24/2019 just in time for the Holidays!

The move-in process included long-term housing stability plans, provision of furniture and other household items to ensure immediate stability, and ongoing staff check-ins to facilitate positive client-to-client dynamics within the home. Since move-in, all clients have received follow-up case management services, such as assistance with medical appointments and increasing income. One of these clients is fleeing domestic violence.

Services provided this quarter include 16 unduplicated client contacts, and 37 life skill interventions, such as defining consistent and clear boundaries within the community, goals-setting, managing income, and reinforcing client resilience for seven residents residing in Albany.

During the second quarter, HNs received additional information regarding UC Berkeley resources for students living in the UC Village who require rental assistance resources. The HNs referred two students to this resource this quarter.

The relationship between the Hope team, Albany residents, and public service providers has grown over this last quarter. HN has worked closely with the Albany Police Department to support homeless individuals, as well as Albany residents. Occasionally, an Albany resident seeks our support when dealing with a homeless individual. We believe this endeavor has positively impacted client behavior.

Challenges in Quarter 2

Lack of affordable housing in the current market remains an issue. BFHP has a relationship with one landlord that has worked with our agency for many years. The trust that we have built benefits the Albany program. We have recently received an introduction to a new local landlord. This person is willing to work with BFHP because of a positive reference. We will continue to search for property owners, and low-income housing units to support Albany clientele.

Another challenge is out of the four PSH matches, one client declined three matches offered and two of the four clients have not received an official unit or voucher, yet.










