**A RESOLUTION OF THE ALBANY CITY COUNCIL, COUNTY OF ALAMEDA,
STATE OF CALIFORNIA, DECLARING THE RESULTS OF THE GENERAL
MUNICIPAL ELECTION HELD ON NOVEMBER 3, 2020**

WHEREAS, a General Municipal Election was held and conducted in the City of Albany, County of Alameda, State of California, on November 3, 2020, as required by law; and

WHEREAS, it appears that notice of said election was duly and legally given, that accessible voting locations were properly established, that election officials were appointed and election supplies furnished, and that in all respects said election was held and conducted, and the votes cast thereat received and canvassed and the returns thereof made and declared in the time, form and manner required by law; and

WHEREAS, due to the pandemic, said election was conducted by vote-by-mail ballots mailed by Alameda County Registrar of Voters to all registered voters and accessible voting locations established as required by law by Alameda County Registrar of Voters; and

WHEREAS, the City Council of the City of Albany met on Monday, December 14, 2020 at its special meeting to canvass the returns of said election as provided by the Alameda County Registrar of Voters, as a result of which the City Council finds the number of votes cast, the names of the persons voted for, and other matters required by law to be as hereinafter stated.

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF ALBANY DOES
HEREBY RESOLVE AS FOLLOWS:**

That said Municipal Election was held and conducted in the City of Albany on Tuesday, November 3, 2020, at the time and in the form and manner as required by law.

That the whole number of votes cast in the City of Albany was 12,284.

2 of votes given in each accessible voting locations to each of said persons, together with the whole
3 number of votes which they received in the entire City, as included on the attached Certification
4 from the Alameda County Registrar of Voters.

16 Unified School District Board of Education for a term of four (4) years; also that

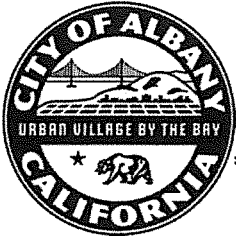
17 **MEASURE BB** on the ballot did receive the required votes, and therefore, was passed by
