**A RESOLUTION OF THE ALBANY CITY COUNCIL APPROVING
THE APPROPRIATION OF PEG FUNDS IN AN AMOUNT
NOT TO EXCEED \$60,000 FOR THE PURCHASE OF ADDITIONAL
KALB MEDIA STORAGE, CAMERA REPLACEMENT IN
THE COUNCIL CHAMBERS AND ASSOCIATED EQUIPMENT**

WHEREAS, Public, Education, and Government Access Television (PEG) funds are designated only for capital expenditures that finance day-to-day operations of public-access channels such as video production/streaming equipment, media storage and archiving equipment, computer/technology, TV monitoring technology, vehicle for broadcasting or transport, renovation and construction of facilities, and office furniture; and

WHEREAS, the City’s broadcasting infrastructure needs updated equipment to increase media storage and replace outdated cameras in the Council Chambers; and

WHEREAS, portable, external hard drives are used to manage and store video files which are large and require a considerable amount of space to store beyond the scope of typical City servers and cloud storage options; and

WHEREAS, media storage is nearly full and additional storage is needed to organize and manage existing content and provide enough space to easily accommodate workflow for the next year; and

WHEREAS, the remote controlled cameras installed in 2009 in the Council Chambers have a 10 year service life have had intermittent issues it is advisable to keep all components of the system up to date and in good repair.

1 **NOW, THEREFORE, BE IT RESOLVED,** that the Albany City Council hereby
2 approves the appropriation of PEG funds in an amount not to exceed \$60,000 for the
3 purchase of additional KALB media storage, camera replacement in the Council Chambers
4 and associated equipment.
